Meeting Minutes March 12, 2024

1. Call to order.

Meeting was called to order at 5:10 p.m. Commissioners present: Ericka Lang, Dave Kieck, David Bartoshevich, Aleta Schilling and Melissa Ellis.

2. Approval of December 19, 2023 minutes.

Shilling moved to approve, seconded by Kieck. Motion passed.

3. Discussion/possible motion of 2023 grant recipient financial reports and report requirements.

All 2023 grant recipients provided a summary of how funds were used. A few nonprofits provided proof of expenditures. Commissioners agreed going forward to require sales receipts or other financial documentation to show expenditure details for approved items. Grant agreements will specify requirements.

4. Discussion/possible motion regarding 2023 grant recipient remaining balances.

Several grant recipients had unspent funds: Friends of Grant Park, South Milwaukee Historical Society, Warm Up South Milwaukee, and Lions Club. All agreed that the nonprofits were approved to use funds for approved projects, completed within 12 months of award. Expenditures may continue through May 31, 2024 and remaining balances shall be returned to the city, including proof of expenditures of items purchased after the financial reports were provided to the city. It was iterated that direct payments to individuals outside of a contract are not eligible. Lang stated an error in meeting materials: the Police Department spent 100% of 2023 awarded funds.

5. Discussion and motion to recommend eligible nonprofit requests to apply for 2024 Bucyrus Civic Grant funds.

Commissioners received Letters-of-Interest from eight organizations: South Milwaukee Friends of the Library, Friends of Grant Park, South Milwaukee Historical Society, Warm Up South Milwaukee, Friends of Mill Pond, Art Works, Human Concerns and South Milwaukee Celebrations Committee.

Eligible projects and invitations to apply were: South Milwaukee Friends of the Library, South Milwaukee Historical Society, Warm Up South Milwaukee, Art Works, and South Milwaukee Celebrations Committee. All other projects were determined ineligible per program criteria. Applications and supporting materials are due April 30, 2024. Applicants will be invited to present projects in May for final approvals. The 2024 available Civic Grant fund is \$50,000. Total requests were over \$84,000 with two applications not providing cost estimates.

6. Schedule next meeting.

The next meeting is scheduled May 14th at 5 p.m. for presentations and award allocations.

7. Adjourn.

Meeting adjourned at 6:21 p.m.

The annual grant budget is \$50,000 with seven nonprofits receiving funding.

Dear Ericka,

The Friends of the South Milwaukee Library wishes to request eligibility to apply for a South Milwaukee Bucyrus Civic Grant.

The Friends of the South Milwaukee Library would use the 2025 Bucyrus Civic Grant to:

- **Add video games and players for young adults and children.**

The staff is receiving a growing number of requests for video games for young adults, teens and some older children. The library would like to better serve this difficult-to-reach, and therefore under served, population but lacks the funds to add this resource. We want to purchase two game systems, extra remotes to expand the number of people able to play at one time, a game cartridge library spanning multiple ages and security cases to prevent theft. The estimated cost of this project is \$2,200.

- **Host a visit from a popular children's author.**

Authors inspire and encourage literacy, creativity, motivation, organization, and communication — all fundamental skills for young people. We propose partnering with South Milwaukee schools to help teachers capitalize on the author's visit with various reading and writing activities that use the author's book to build skills and possible author talk(s) at school. We want to purchase multiple copies of the book, prior to the visit, so the schools and their students can capitalize on all aspects of the author's visit. Depending on the author, a reasonable fee for the visit is between \$2,000-\$5,000 plus travel and hotel costs. A high-end estimate of the total cost should not exceed \$6,000.

- **Beautify the library entrance.**

The current entrance to the library is a concrete jungle with no seating, little visual interest and almost no green space. We envision a fun, colorful art installation appropriate for a library, a sturdy, colorful bench and an artificial green wall to beautify and soften the library entrance. All items can be moved to a new location, if needed. The estimated cost of this project is \$13,180.

The development of these resources will benefit South Milwaukee residents of all ages.

Dear Ericka,

The Bucyrus Museum and Bucyrus Club are hosts to more than 15,000 guests each year for various co-booked events, including but not limited to Great Lakes Cruise Line visitors, weddings, corporate events, civic events, funeral luncheons, etc. In addition to events, we each receive daily visits from restaurant and museum patrons as well.

At our recent Board of Directors meeting, the subject of patron safety was addressed along with our internal plans to make sure we're prepared for emergency situations. Our Board underwent AED training last year and just completed Narcan training. The building currently has one AED located on the east end of the first floor. With that, we were advised that the building size warrants two additional units, one on the west side (Grand Ballroom) and one on the second floor (museum).

The patrons of the Bucyrus Museum and Bucyrus Club would benefit from the additional proximity of an AED by decreasing the reaction time to address a medical emergency situation where minutes are critical for life saving measures to begin. The units would be purchased by the Bucyrus Museum through the South Milwaukee Fire Department's agreement with their service provider at cost, and installation would be at the expense of the Bucyrus Museum. The total cost for two units is estimated to be \$4,800.00.

We would like to thank you and the Civic Grant Commission for consideration of our request to improve the safety of the many visitors to South Milwaukee that the Bucyrus Club and Bucyrus Museum host every year. Bucyrus Civic Grant Program Manager:

Gearbox Labs was founded in 2019 as a 501(c)(3) non-profit, all-volunteer organization and moved to South Milwaukee in September of 2024 to better serve communities in Milwaukee.

Gearbox Labs was founded to address shortfalls in STEM education, specifically technology, engineering, and coding. To do this Gearbox Labs creates cutting edge and rigorous curricula and experiences for educators and students. We work in most school districts in Milwaukee County providing STEM curricula, professional development, and support for science and engineering fairs.

Gearbox Labs also produces the Maker Faire Milwaukee at Discovery World each November.

After moving to South Milwaukee, Gearbox Labs began supporting South Milwaukee Middle School's STEM Program with its participation in NASA's Techrise (which the team won in 2025) and Samsung Solve for Tomorrow (which the team was a state finalist in 2024).

We have successfully provided over 100 workshops for free around the state with support from multiple foundations over the past 5 years.

This letter of interest is to notify our intent, if invited, to apply for a \$2500 grant from the Bucyrus Civic Grant Program. We have reviewed the requirements for the grant submission and do meet all the requirements. With this grant Gearbox Labs would provide two free one day workshops, one for educators and a second workshop for students on engineering, electronics, and coding. Workshops participants would receive a starter electronics kit, 240-page project book, and instruction.

We have initiated a conversation with the South Milwaukee Public Library to host the workshops and with this grant, Gearbox Labs would be able to provide an engaging STEM program for free to our community and our community's educators.

Thank you for your consideration of the South Milwaukee Heritage Days Parade participation in the South Milwaukee Bucyrus Civic Grant.

The South Milwaukee Heritage Days Parade is a highlight of the Heritage Days Weekend, with approximately 6,000 spectators and averaging 110 units. These units consist of local and state celebrities, patriotic units, bands of many genres, drum corps and other entertainment units.

This year, we seek to honor the legacy of the honorable Chester "Chet" Grobschmidt for his lifelong service and dedication to our community. Mr. Grobschmidt was a WWII Navy veteran, a nine-year alderman, and served as Mayor of South Milwaukee for 28 years. Additionally, he dedicated 42 years of service to Bucyrus-Erie and was deeply committed to his faith and family. His unwavering loyalty to our city and its people makes him a fitting figure to recognize through this year's parade.

To commemorate his contributions, we are requesting a **\$2,250 grant** to support a special tribute in his honor. Our proposed plans include:

I am writing to submit a proposal for the Bucyrus Foundation Civic Grant to establish a self-contained urban growing unit (SCUGU) in South Milwaukee. This innovative project will transform a shipping container into a hydroponic growing facility that is solar-powered and fueled by harvested rainwater.

Measuring 8 feet by 40 feet, and utilizing vertical grow space, the SCUGU will yield the equivalent of 3 acres of traditional farmland, producing 2 to 6 tons of fresh, sustainable produce year-round. Our partnership with the South Milwaukee School District will allow us to use the unit as a living classroom, providing hands-on agricultural education and job opportunities for students in our community.

We are also committed to addressing food insecurity and plan to donate half of the harvest to Human Concerns, benefiting residents in need. The estimated budget for this project is \$30,000, which includes \$20,000 for materials and \$10,000 for a part-time manager. Ellen Colby, Eco-Agronomist and Founder of The MARM Farm, will oversee the project.

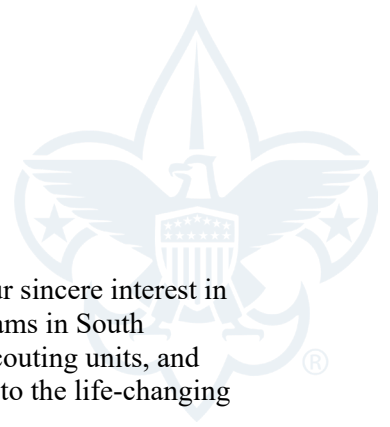
