

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *5/27/19 – 6/02/19*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **268** calls for service.

DISORDERLY CONDUCT

Officers were dispatched to a report of two individuals fighting inside a vehicle in a parking lot in the 2900 Block of South Chicago Avenue on May 31st. Officers spoke with a 31-year-old Greenfield man who stated he was struck by a 26-year-old Milwaukee woman during an argument over relationship issues. The Milwaukee woman was arrested and referred to the Milwaukee County District Attorney's on a charge of Disorderly Conduct-Domestic Violence Related. The Greenfield man was arrested on warrants with the Greenfield Police Department and the Delafield Police Department. He posted the required bond amount on one of the warrants and was released on a Personal Recognizance Bond on the other.

Officers were dispatched to a report of a woman acting disorderly at a business in the 2900 Block of South Chicago Avenue on June 1st. Upon arrival, officers spoke with a manager who stated the woman began screaming profanities towards staff members after being advised to move her parked vehicle from the fire lane. Using vehicle registration information provided by employees, officers were able to identify the disorderly individual as a 31-year-old South Milwaukee woman and when contacted, she stated she parked in the fire lane because she was in a hurry. She was issued a citation for Disorderly Conduct.

OPERATING WHILE INTOXICATED

An officer on patrol observed two vehicles collide near 15th and Manitoba Avenues on June 1st. No injuries were reported and the driver of one of the vehicles, a 19-year-old Racine woman, admitted to smoking marijuana and drinking alcohol prior to the accident. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated, Underage Consumption of Alcohol, Possession of Marijuana, and Possession of Drug Paraphernalia. After receiving her citations, she was released to a sober, responsible adult.

Officers were dispatched to a business in the 1200 Block of Marquette Avenue as employees were concerned a female inside appeared to be too intoxicated to drive. Officers spoke with a 36-year-old South Milwaukee woman who had driven to the business and showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-First Offense and Prohibited Blood-Alcohol Concentration. She was released to a sober, responsible adult.

ARREST WARRANT

An officer on patrol noticed a license plate did not match the vehicle it was affixed to in the 2300 Block of 10th Avenue on June 1st and a traffic stop was initiated. The driver, a 66-year-old South Milwaukee man, was found to have confirmed warrants with the South Milwaukee Police Department and the Milwaukee County Sheriff's Department. He was arrested and taken to the police station where he signed a Personal Recognizance Bond on the South Milwaukee warrant before being turned over to Milwaukee County Sheriff's deputies on their warrant.

An officer initiated a traffic stop on a vehicle for speeding in the 1800 Block of Marquette Avenue on May 31st. The driver, a 27-year-old Milwaukee woman was issued citations for Speeding and Operating after Suspension. Her passengers, a 26-year-old West Allis man and a 41-year-old Milwaukee woman, were found to have confirmed warrants with the Oak Creek Police Department and the Juneau County Sheriff's Department. They were arrested and the West Allis man was turned over to officers from the Oak Creek Police Department while the Milwaukee woman was taken to the Milwaukee County Criminal Justice Facility to await pick up from Juneau County Sheriff's deputies.
