

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *6/10/19 – 6/16/19*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **378** calls for service.

DISORDERLY CONDUCT

Officers were dispatched to a report of a disorderly individual at a business in the 200 Block of North Chicago Avenue who had jumped over a counter in an attempt to take merchandise and was shouting at employees. Officers located a man matching the description of the disorderly subject and observed him throw down several gift cards. The man attempted to flee the area and was arrested by officers with the assistance of citizens. The man, who had multiple different forms of identification on him, was eventually identified as a 24-year-old Detroit, Michigan man. He was taken to the Milwaukee County Criminal Justice Facility on charges of Forgery (2 Counts), Disorderly Conduct, and Resisting/Obstructing Arrest.

Officers were dispatched to a report of an unknown person kicking a door in the 600 Block of Mackinac Avenue on June 15th. Upon arrival, officers located a 29-year-old Milwaukee woman who stated her phone was stolen in Milwaukee and she was attempting to locate it. She was briefly detained and was advised the GPS function on the phone did not provide an exact location but rather a broad area of where the phone may be. The phone was not located at the scene and the caller did not wish to pursue the incident any further. The woman was released after being advised to seek police assistance before going to various homes to attempt to recover her property on her own.

RETAIL THEFT

Employees at a business in the 1000 Block of Marquette Avenue reported two individuals entered the store and took cases of hand tools without paying for them. The subjects entered a vehicle parked in front of the store, which then left the area. The vehicle was located a short time later in the city of Cudahy and a Cudahy police officer stopped it on Pennsylvania Avenue as South Milwaukee officers arrived. The tools were recovered and a 51-year-old Oak Creek woman, A 29-year-old Oak Creek man, and a 16-year-old Milwaukee boy were all arrested and brought to the police station. The man and the woman were issued citations for Retail Theft and Contributing to the Delinquency of a Minor while the boy was issued citations for Retail Theft and Obstructing after he originally gave officers a false name.

Officers were dispatched to a business in the 2900 Block of South Chicago Avenue on June 15th for a report of a subject attempting to leave without paying for a bottle of alcohol. Officers spoke with a 42-year-old Oak Creek man who relinquished the alcohol when confronted by employees at check-out. Video surveillance from earlier in the day showed the same man enter the store and conceal another alcohol bottle in his pants before leaving without paying for it. He was arrested and taken to the police station where he was issued a citation for Retail Theft and released. Later that evening, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of an individual attempting to take items from the store. Officers located the same 42-year-old Oak Creek man who had multiple charging cords in his possession that he claimed he had bought but could not produce a receipt. The man eventually admitted to taking the items from the store. He was arrested again and issued another citation for Retail Theft.

OPERATING WHILE INTOXICATED

South Milwaukee Street Department personnel reported observing a man drinking out of a liquor bottle and driving a vehicle near Hawthorne Avenue and Lake Drive on June 13th. The Street Department personnel were able to position their vehicle to prevent the man from driving further as he appeared to be passed out as his car slowly drove into the Street Department vehicle. A 44-year-old South Milwaukee man was arrested and issued citations for Operating While Intoxicated-First Offense, Drinking Open Intoxicants in a Motor Vehicle, and Possession of Open Intoxicants in a Motor Vehicle.
