

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *7/22/19 – 7/28/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **334** calls for service.

### **BATTERY**

Officers were dispatched to a report of a female being battered by a male in the 800 Block of Minnesota Avenue on July 28<sup>th</sup>. Upon arrival, a 29-year-old South Milwaukee woman reported that a 26-year-old male acquaintance entered her residence through a balcony door and battered her and another male before leaving the area. Following an investigation, the man was charged by the Milwaukee County District Attorney's Office with Criminal Trespassing and Battery.

Emergency personnel at St. Luke's South Shore hospital in Cudahy notified South Milwaukee police on July 28th of a 29-year-old South Milwaukee man who arrived in the Emergency Room with cuts to his neck that he claimed occurred in South Milwaukee. There is no danger to the public as an investigation continues and officers follow up on various statements made by the victim.

### **OPERATING WHILE INTOXICATED**

Officers were dispatched to a report of a man sleeping against a tree in the 1400 Block of Missouri Avenue on July 27<sup>th</sup>. The man awakened and began to leave in a vehicle as officers arrived on scene. A traffic stop was conducted and the driver, a 61-year-old Cudahy man, showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-5<sup>th</sup> Offense and Operating After Revocation.

## **DISORDERLY CONDUCT**

**Officers were dispatched to a report of an individual acting disorderly and refusing to leave an establishment in the 1200 Block of Milwaukee Avenue on July 27<sup>th</sup>. Officers spoke with a 38-year-old South Milwaukee man who appeared to be intoxicated. The man admitted to not leaving the business when asked to do so. He was arrested and issued a citation for Disorderly Conduct.**

**An officer initiated a traffic stop on a vehicle in the 1600 Block of Rawson Avenue due to improper registration on July 24<sup>th</sup>. The male driver did not have a driver's license on him and claimed the vehicle belonged to his girlfriend. The information the driver provided to officers could not be verified. He was advised he would be detained and taken to the police station to be positively identified. The man admitted to providing the false information because he had a warrant and he was identified as a 57-year-old South Milwaukee man. The man had a confirmed warrant with the Milwaukee County Sheriff's Department for Operating While Intoxicated-3<sup>rd</sup> Offense and Recklessly Endangering Safety. He was arrested and issued citations for Operating After Suspension and Obstructing an Officer.**

**An officer observed a van driving with its side door open in a parking lot in the 200 Block of North Chicago Avenue on July 25<sup>th</sup>. The officer also observed an individual jump out of the vehicle as it was moving. The vehicle then reversed and the individual jumped back in the vehicle which then parked as the officer stopped it. The driver, an 18-year-old Arkdale, Wisconsin man, originally provided false information as to his identity but eventually provided his correct information. A 17-year-old Cudahy girl was a passenger in the vehicle and she was found to have a valid truancy warrant with the Cudahy Police Department. She also admitted to drinking alcohol earlier. Both were arrested and brought to the police station where the man was issued a citation for Obstructing an Officer and the girl was issued a citation for Underage Consumption of Alcohol. She signed a Personal Recognizance Bond on the Cudahy warrant before being released to her father.**
