

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *7/29/19 – 8/6/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **379** calls for service.

### **DISORDERLY CONDUCT**

Officers were dispatched to a report of individuals involved in an altercation in the 500 Block of Madison Avenue on August 4<sup>th</sup>. Upon arrival witnesses stated a 23-year-old South Milwaukee man and a 34-year-old Oak Creek man were punched by two females inside a business in the area. A 28-year-old Muskego woman and a 28-year old Franklin woman were arrested and issued citations for Battery and Disorderly Conduct.

Officers were dispatched to a report of two subjects involved in an altercation in the 600 Block of Manistique Avenue on July 29<sup>th</sup>. Upon arrival officers spoke with a 24-year-old South Milwaukee man and a 39-year-old South Milwaukee man who both admitted to being involved in a mutual fight. Both were arrested and issued citations for Disorderly Conduct.

A 33-year-old South Milwaukee woman reported a 38-year-old Oak Creek man was refusing to leave her residence in the 3300 Block of Marina Road on August 4<sup>th</sup>. The man requested a bus pass after being warned on his actions and advised to leave the residence. He was provided with a bus pass and given a ride to the bus stop at North Chicago and College Avenues. A short time later, officers were dispatched to a restaurant in the 100 Block of North Chicago Avenue for the same man bothering customers and refusing to leave. He was arrested and issued a citation for Disorderly Conduct.

## **WARRANT ARREST**

An officer observed a vehicle parked and occupied in the 100 Block of Hawthorne Avenue near the Grant Park Golf Course during the overnight hours on August 4<sup>th</sup>. The occupants, a 22-year-old West Allis man and a 19-year-old South Milwaukee woman were warned and advised on park hours. The man was arrested on a confirmed warrant with the Wisconsin Department of Corrections and he was issued a citation for Possession of Drug Paraphernalia for a marijuana pipe that was located in the vehicle. He was taken to the Milwaukee County Criminal Justice Facility on the warrant.

## **OPERATING WHILE INTOXICATED**

Officers were dispatched to a report of a minor motor vehicle accident occurring in the drive-thru lane of a restaurant in the 2700 Block of South Chicago Avenue on August 4<sup>th</sup>. Upon arrival, a 24-year-old South Milwaukee man reported his vehicle was struck from behind by a vehicle driven by a 44-year-old South Milwaukee man. The 44-year-old man showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-2<sup>nd</sup> Offense and Prohibited Alcohol Concentration-2<sup>nd</sup> Offense.

## **CRIMINAL DAMAGE TO PROPERTY**

Residents in the 2400 Block of Nicholson Avenue reported being awakened by a loud sound and their patio window shattering on August 3<sup>rd</sup>. A small hole was also located in the wall to a neighboring apartment. Officers spoke with a 41-year-old South Milwaukee man in the neighboring apartment who was intoxicated. A firearm was also located on the man's kitchen table and it appears that he accidentally discharged that weapon. He was arrested and charged by the Milwaukee County District Attorney's Office with Endangering Safety By Use of a Dangerous Weapon (Under the Influence of Intoxicants), Endangering Safety by Use of a Dangerous Weapon, and Bail Jumping. He was also issued citations for Possession of Marijuana and Possession of Drug Paraphernalia after marijuana and marijuana pipes were located in the apartment.
