

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *8/19/19 – 8/25/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **313** calls for service.

### **DISORDERLY CONDUCT**

On August 19<sup>th</sup>, a female caller reported a male subject yelled at her after asking for a cigarette and then began driving his van in circles in a parking lot in the 2900 Block of South Chicago Avenue. Officers spoke with a 35-year-old Milwaukee man who admitted to yelling at the caller and showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating Under The Influence-First Offense and Disorderly Conduct.

Officers were dispatched to a report of a male and female bothering customers in front of a store in the 2900 Block of South Chicago Avenue on August 20<sup>th</sup>. Officers spoke with a 37-year-old Milwaukee woman and a 49-year-old Milwaukee man who were warned earlier in the evening regarding panhandling in the area. Both were arrested and issued citations for Disorderly Conduct. The man was also issued a citation for Retail Theft after two bottles of alcohol from the store were found in a backpack he was wearing.

Officers were dispatched to a report of individuals fighting in the 1300 Block of Michigan Avenue on August 20<sup>th</sup>. Officers spoke with a 31-year-old South Milwaukee man who stated he was involved in a verbal argument with his girlfriend when a 45-year-old South Milwaukee man approached and struck him. Both men were arrested and issued citations for Disorderly Conduct. The 31-year-old man was also issued a citation for Criminal Damage to Property after he threw the 45-year-old man's phone causing it to break.

## **LIQUOR VIOLATION**

An officer on patrol observed a male urinating on a fence in the 1100 Block of Milwaukee Avenue on August 24<sup>th</sup>. The 19-year-old South Milwaukee man, who had no identification on him, appeared intoxicated and showed signs of impairment. He was arrested and issued citations for Disorderly Conduct and Underage Consumption of Alcohol. It was determined the man obtained the alcohol from a nearby tavern and a 21-year-old Cudahy woman bartending there was issued a citation for Sale of an Intoxicant to an Underage Person.

## **DRUG INVESTIGATION**

An officer on patrol noticed a vehicle bearing suspended license plates that did not match the vehicle on August 24<sup>th</sup> and a traffic stop was initiated at 15<sup>th</sup> Avenue and Parkway Drive. The driver, a 19-year-old Milwaukee man, stated he just purchased the vehicle and the plates were from another family member's car. While speaking with the driver, the officer detected a strong odor of marijuana. Upon searching the vehicle, marijuana was located in the glove box. The man was arrested and issued a citation for Possession of Marijuana.

An officer on patrol noticed a vehicle fail to stop for a flashing red light at 15<sup>th</sup> and Rawson Avenues on August 20<sup>th</sup>. The officer followed the vehicle and initiated a traffic stop in the 1300 Block of Manitoba Avenue. Upon approaching the vehicle, a strong odor of marijuana was present and the driver, a 19-year-old South Milwaukee woman was detained. A small amount of marijuana was located in the vehicle, along with two narcotic pills the woman did not have a prescription for. She was arrested and issued citations for Failure to Stop at a Traffic Signal, Operating While Suspended, Failure to Wear a Seatbelt, and Resisting a Police Officer. The woman was also given an order-in date with the Milwaukee County District Attorney's Office Community Prosecutor for a referred charge of Possession of a Controlled Substance.
