

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *10/7/19 – 10/13/19*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **254** calls for service.

VEHICLE ACCIDENT

On October 9th, officers were dispatched to a motor vehicle accident involving three cars at the intersection of 15th Avenue and the Oak Creek Parkway. A vehicle driven by a 21-year-old South Milwaukee man failed to yield from the stop sign and entered the intersection where it was struck by a vehicle driven by a 37-year-old South Milwaukee woman. The man's vehicle spun around and was struck by a third vehicle driven by a 36-year-old South Milwaukee woman. The man was issued citations for Failure to Yield the Right of Way from a Stop Sign and Operating After Revocation.

OPERATING WHILE INTOXICATED

On October 12th, officers received a report of a vehicle travelling Southbound in the Northbound lane of traffic on 10th Avenue near Marquette Avenue. Upon arrival, officers located two vehicles stopped near 9th and Marshall Avenues. A 30-year-old South Milwaukee man on the scene told officers the vehicle traveling the wrong way nearly struck his vehicle. The man was able to get the other driver to stop and take possession of his keys before calling for police. The other driver, a 56-year-old Miami, Florida man, was arrested and issued a citation for Operating While Intoxicated-First Offense.

RETAIL THEFT

On October 9th, officers were dispatched to a report of a man leaving a business in the 200 Block of North Chicago Avenue without paying for items. Store personnel reported the man attempted to return items for cash using a receipt from a different store that did not match the items he had and when confronted, the man fled the store. With assistance from officers from the Cudahy Police Department, a man who matched the description of the suspect was located on College Avenue. He was identified as a 30-year-old Milwaukee man and admitted he was the individual that fled the business. He was arrested and issued citations for Retail Theft and Trespassing as he was not allowed in the business due to prior similar incidents in other jurisdictions.

On October 12th, officers were dispatched to a report of an individual intentionally placing lower priced UPC symbols on higher priced merchandise in a business in the 200 Block of North Chicago Avenue. Officers spoke with a 25-year-old Milwaukee man who store employees observed removing price symbols on merchandise in the store. The man was in possession of higher priced store items that had the incorrect price symbols placed over the original ones. He was arrested and issued a citation for Retail Theft-Second Offense.

On October 10th, officers received information that an individual with warrants was near a business in the 2900 Block of South Chicago Avenue. Officers made contact with a 42-year-old South Milwaukee woman who held two confirmed warrants with the West Allis Police Department. She was also in possession of items from the business that she had not paid for. She was arrested and taken to the police department where she was issued a citation for Retail Theft and signed personal recognizance bonds on the West Allis warrants.
