

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *10/21/19 – 10/27/19*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past week the South Milwaukee Police Department responded to **268** calls for service.

FIRE CALL

On October 23RD, officers were dispatched to a report of an individual starting a fire in a garbage can near the bus stop at North Chicago and College Avenues. South Milwaukee Fire Department personnel extinguished a small garbage can fire while officers searched the area. Cudahy Police Department officers located a 37-year-old Milwaukee man who matched the description of the suspect on Packard Avenue in the city of Cudahy. Two more garbage can fires were located in Cudahy along the route between the South Milwaukee call and where the man was located. The man admitted to starting the garbage cans on fire and he was arrested. He was taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Arson and Negligent Handling of Burning Materials.

WARRANT ARREST

On October 22nd, a 26-year-old South Milwaukee man came to the police department to turn himself in on a warrant. He was found to have a confirmed felony warrant with the Wisconsin Department of Corrections. The man was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrant.

On October 24th, officers received information that an individual who held warrants with the Milwaukee County Sheriff's Department was at a residence in the 600 Block of North Chicago Avenue. Officers located a 36-year-old Milwaukee man who held a confirmed felony warrant with the Milwaukee County Sheriff's Department for Felon in Possession of a Firearm. The man was arrested without incident and taken to the police department before being turned over to Milwaukee County Sheriff's deputies on the warrant.

DISORDERLY CONDUCT

On October 26TH, officers were dispatched to a report of a man and woman arguing in the 1200 Block of Marquette Avenue. Officers spoke with a 36-year-old South Milwaukee man and a 31-year-old Milwaukee woman who were involved in the argument. The woman told officers the man pushed her to the ground. He was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence. The woman was found to have two confirmed warrants with the Waukesha County Sheriff's Department. She was arrested and taken to the Waukesha County Jail on the warrants.

STOLEN VEHICLE

An officer on patrol noticed a motorcycle parked in the Fire lane near a business in the 200 Block of North Chicago Avenue on October 23rd. After checking the registration on the motorcycle, it was found to have been reported stolen through the Veteran's Affairs Police Department. The officer was able to locate and identify a 37-year-old Milwaukee man as the operator of the motorcycle. The man claimed he received the motorcycle from a friend and did not know it was stolen. The owner of the motorcycle was contacted and he did not know the man who was operating the motorcycle nor the friend who the man stated he received it from. The Milwaukee man was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Operating a Motor Vehicle Without Owner's Consent.
