

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *11/11/19 – 11/17/19*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past week the South Milwaukee Police Department responded to **244** calls for service.

DISORDERLY CONDUCT

On November 17th, officers were dispatched to a report of two individuals acting disorderly at a business in the 2300 Block of 10th Avenue. Officers spoke with a 37-year-old South Milwaukee man and a 33-year-old Cudahy man who each stated the other was attempting to provoke a fight. No actual physical fight took place but both men were loud and boisterous. Both were arrested and issued citations for Disorderly Conduct.

TRESPASS

On November 13th, officers were dispatched to the 900 Block of Madison Avenue after a citizen reported observing an individual inside a vacant residence. Officers made contact with a 76-year-old South Milwaukee man who was found to have been recently evicted from the building. The eviction was confirmed with the Milwaukee County Sheriff's Department and the man was arrested and taken to the police station where he was issued a citation for Trespassing

BATTERY

On November 12th, officers were dispatched to the 900 Block of Columbia Avenue for a report of a male and female involved in an altercation. Officers spoke with a 19-year-old South Milwaukee man and a 21-year-old South Milwaukee woman who were involved in an argument. A witness observed the man push the woman down. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Battery.

WARRANT ARREST

On November 12th, a citizen reported an individual with multiple warrants was in the 400 Block of Marquette Avenue and had left the area in a vehicle. Officers located the vehicle and initiated a traffic stop. The driver, a 35-year-old Rib Lake man was found to have confirmed warrants with the Milwaukee County Sheriff's Department and the Washington County Sheriff's Department. He was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrants.

On November 16th, a 29-year-old South Milwaukee man came to the police station stating he had a warrant and wanted to turn himself in. The man was found to have a confirmed warrant with the Wisconsin Department of Corrections and he was arrested. He was taken to the Milwaukee County Criminal Justice Facility on the warrant.

RETAIL THEFT

On November 14th, officers were dispatched to a report of an individual leaving a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 26-year-old South Milwaukee woman who admitted to taking the items. She was also found to have drug paraphernalia in her possession. She was arrested and taken to the police station where she was issued citations for Retail Theft and Possession of Drug Paraphernalia.
