

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *11/18/19 – 12/1/19*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **490** calls for service.

LAW ENFORCEMENT ASSISTANCE

On November 28th, officers from the Oak Creek Police Department notified South Milwaukee Police Department officers an individual wanted for a criminal damage to property incident in their city was in a vehicle last seen entering South Milwaukee. The vehicle was located near 15th and Park Avenues and a traffic stop was initiated with officers from the South Milwaukee, Oak Creek, and Cudahy Police Departments providing assistance. The suspect, a 34-year-old Cudahy man, was a passenger in the vehicle and he was arrested and turned over to officers from the Oak Creek Police Department.

RETAIL THEFT

On November 28th, officers were dispatched to a report of a disorderly customer who threatened employees at a business in the 1100 Block of Marquette Avenue and left the store without paying for items. Officers were also advised the individual was attempting to leave the scene in a vehicle. Officers arrived and initiated a traffic stop on the vehicle. The items reported taken from the store were located in the vehicle along with drug paraphernalia and the driver, a 26-year-old South Milwaukee woman, was arrested. She was taken to the police department where she was issued a citation for Possession of Drug Paraphernalia before being referred to the Milwaukee County District Attorney's Office on charges of Retail Theft, Disorderly Conduct and Resisting/Obstructing.

On November 20th, officers were dispatched to a report of an individual leaving a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 42-year-old South Milwaukee woman who was being detained by store security personnel who observed her attempt to leave the store without purchasing the items. Drug paraphernalia was also located in her purse. She was arrested and taken to the police department where she was issued citations for Retail Theft and Possession of Drug Paraphernalia.

On November 18th, officers were dispatched to a report of an individual leaving a business in the 2900 Block of South Chicago Avenue with a cake that was not paid for. Officers located a 23-year-old Milwaukee man inside a nearby business who matched the description given and he admitted to taking the cake without paying for it. He was arrested and taken to the police station where he was issued a citation for Retail Theft.

DISORDERLY CONDUCT

On November 24th, an officer stopped to speak with an individual he observed yelling in the 1000 Block of Milwaukee Avenue. While the 38-year-old South Milwaukee man was speaking with the officer, a 40-year-old Oak Creek man approached and the two individuals began arguing. Both were arrested and taken to the police station. The South Milwaukee man was issued a citation for Disorderly Conduct while the Oak Creek man was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct, Resisting/Obstructing, and Criminal Damage to Property after he became uncooperative and caused damage in the jail cell.
