

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *12/16/19 – 1/5/20***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past 3 weeks the South Milwaukee Police Department responded to **718** calls for service.

### **DISORDERLY CONDUCT**

On January 1<sup>st</sup>, officers were dispatched to the 800 Block of Hawthorne Avenue for a report of individuals involved in an argument where a firearm was mentioned. Officers made contact with a 38-year-old South Milwaukee woman, a 38-year-old Casa Grande, Arizona woman, and a 35-year old Oak Creek man who stated a 43-year-old South Milwaukee man threatened them with a firearm at a residence in the area. Officers went to the residence and made contact with the South Milwaukee man who refused to come to the door. With the assistance of officers from the Cudahy Police Department, a forced entry was made and the man was taken into custody. He was arrested and taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Endangering Safety By Use of a Dangerous Weapon and Disorderly Conduct While Armed.

On December 19<sup>th</sup>, officers were dispatched to a report of individuals yelling in the Police Department parking lot in the 2400 Block of 15<sup>th</sup> Avenue. Officers made contact with a 34-year-old Racine man and a 32-year-old Racine woman who were involved in an argument regarding their child. The man became uncooperative with officers and was arrested. It was determined the two were involved in a domestic violence incident in the city of Caledonia prior to coming to the South Milwaukee Police Department. The man was issued a citation for Disorderly Conduct before officers from the Caledonia Police Department took him into custody on the domestic violence investigation.

## **RETAIL THEFT**

**On January 5<sup>th</sup>, officers were dispatched to a business in the 2300 Block of 10<sup>th</sup> Avenue for a report of an individual taking items from the store without paying for them. A store employee stated a 38-year-old South Milwaukee woman concealed candy bars in her pockets and pushed her in an attempt to leave before other customers brought the woman back inside. Store video surveillance showed the woman attempt to leave with the candy bars and she was arrested. She also had two confirmed warrants with the Milwaukee County Sheriff's Office. The woman was referred to the Milwaukee County District Attorney's Office on charges of Battery and Retail Theft before being turned over to Milwaukee County Sheriff's Office deputies on the warrants.**

## **DRUG INVESTIGATION**

**On January 2<sup>nd</sup>, officers were dispatched to a report of a male passed out in the restroom of a business in the 3100 Block of South Chicago Avenue. A 33-year-old South Milwaukee man was located unconscious in the restroom and drug paraphernalia was present. The man was revived by officers and South Milwaukee Fire Department personnel. He was issued citations for Possession of Drug Paraphernalia before being transported to the hospital.**

**On December 26<sup>th</sup>, officers were dispatched to a report of an individual passed out in the basement of a residence in the 1200 Block of Michigan Avenue. Officers located a 44-year-old South Milwaukee man in the residence who was conscious but appeared impaired. The man was out on bail from a prior case with a condition of bail being absolute sobriety. The man was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Bail Jumping.**

**On December 28<sup>th</sup>, officers were dispatched to a report of an individual participating in illegal drug use inside a vehicle near 11<sup>th</sup> and Carroll Avenues. Officers located the vehicle parked in the 200 Block of North Chicago Avenue and made contact with a 35-year-old South Milwaukee man who was standing nearby. The man showed signs of impairment and drug paraphernalia was located inside the vehicle. The man was arrested and issued a citation for Possession of Drug Paraphernalia.**
