

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *2/3/20 – 2/9/20*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **247** calls for service.

INVESTIGATION

On February 7th, officers were called to the 1600 Block of Rawson Avenue to investigate a report of an armed robbery on the street. The investigation revealed the incident stemmed from earlier contact between the victim and an acquaintance. A 21-year-old South Milwaukee man and a 27-year-old Milwaukee man were arrested in connection with this incident. The investigation is ongoing.

DISORDERLY CONDUCT

On February 4th, officers were dispatched to a report of an intoxicated individual refusing to leave the South Milwaukee Library in the 1900 Block of 10th Avenue. Officers spoke with an intoxicated man with an open liquor bottle who would not identify himself. He was arrested and eventually identified as a 39-year-old Milwaukee man. He was taken to the police station where he was issued citations for Disorderly Conduct and Obstructing.

On February 6th, officers were dispatched to a report of an individual taking items and refusing to leave a residence in the 1300 Block of Missouri Avenue. Officers located a 49-year-old Milwaukee man near the residence. The man was found to be in possession of the missing items and he was arrested. He was taken to the police station where he was issued a citation for Theft.

On February 8th, officers were dispatched to a report of two subjects involved in an altercation in the 1700 Block of Milwaukee Avenue. Officers spoke with a 54-year-old South Milwaukee man and a 52-year-old South Milwaukee man who had been arguing. During the argument, the 54-year-old man pushed the 52-year-old man and he was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

RETAIL THEFT

On February 7th, officers were dispatched to a report of an individual leaving a business in the 200 Block of North Chicago Avenue without paying for items. Officers spoke with a 50-year-old Milwaukee man who was being detained by store security after leaving the last point of sale with the items. The man was also previously banned from the business due to prior retail thefts. He was arrested and taken to the police station where he was issued citations for Retail Theft and Trespassing.

OPERATING WHILE INTOXICATED

On February 6th, officers were dispatched to a report of an individual causing a disturbance at a restaurant in the 200 Block of North Chicago Avenue. Officers spoke with a 23-year-old South Milwaukee man at the scene who displayed signs of intoxication. Restaurant employees reported the man entered the store to complain about food he received in the drive-thru. While inside the store, the man damaged a plastic display before officers were called. He was arrested and taken to the police station. He was issued citations for Operating While Intoxicated-First Offense, Criminal Damage to Property, and Disorderly Conduct before being released to a sober responsible adult.

TRAFFIC COMPLAINT

On February 8th, an officer monitoring traffic observed a vehicle traveling on Northbound on Nicholson Avenue speed through the intersection at Rawson Avenue. As the officer began to follow the vehicle, it crossed the median strip and turned onto the frontage road before continuing to Oak Street and 17th Avenue. The vehicle was eventually located in the 1700 Block of Beech Street with a flat tire. The driver, a 26-year-old South Milwaukee woman did not show any signs of impairment. She was issued citations for Unreasonable and Imprudent Speed, Failure to Keep Under Control, Operating a Motor Vehicle Without Insurance, and Operating After Suspension of Vehicle Registration.
