

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *2/25/19 – 3/10/19*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past 2 weeks the South Milwaukee Police Department responded to **483** calls for service.

DRUG INVESTIGATION

A citizen reported an occupied vehicle parked at the dead end in the 1400 Block of Monroe Avenue at on March 8th. As officers arrived, the vehicle began to drive away and officers noticed the occupants were not wearing seatbelts. A traffic stop was conducted near 17th and Milwaukee Avenues and upon approaching the vehicle a strong odor of marijuana was noticed by officers. The driver, a 20 year old Racine man, was arrested for Operating Under the Influence and upon searching the passenger, a 19 year old Racine man, officers located drug paraphernalia and a white powdery substance that later tested positive for cocaine. Both men were arrested and taken to the Milwaukee County Criminal Justice Facility on probation violation holds. The 20 year old man was issued citations for Operating Under the Influence, Failure to Wear Seatbelt, and Operating a Motor Vehicle Without Insurance while the 19 year old man was referred to the Milwaukee County District Attorney's Office on charges of Possession of a Controlled Substance-Cocaine with Intent to Deliver.

Officers were dispatched to an illegally parked occupied vehicle in the 3100 Block of South Chicago Avenue on February 25th. Upon arrival, officers noticed a strong odor of marijuana coming from the vehicle. The driver, a 21 year old Milwaukee man, was arrested and issued citations for Possession of Marijuana, Operating After Suspension, and Operating a Motor Vehicle Without Insurance.

HIT AND RUN ACCIDENT

A resident in the 700 Block of Michigan Avenue reported damage done to a garage door that appeared to be caused by a vehicle on March 4th. With the assistance of a citizen witness report, officers made contact with a 38 year old South Milwaukee man who admitted causing the damage. He was arrested and issued citations for Hit and Run and Obstructing Police.

RETAIL THEFT

A 24 year old Cudahy woman was arrested and issued a citation for Retail Theft- 2nd Offense after she attempted to leave a business in the 2900 Block of South Chicago Avenue without paying for items on March 5th.

A 37 year old South Milwaukee man was arrested and issued a citation for Retail Theft after he attempted to leave a business in the 200 Block of North Chicago Avenue without paying for items at on March 6th.

A 40 year old South Milwaukee woman was arrested and issued a citation for Retail Theft after she attempted to leave a business in the 200 Block of North Chicago Avenue without paying for items on March 9th.

OPERATING WHILE INTOXICATED

Officers were dispatched to a report of two subjects who arrived in a vehicle and were now fighting in the 1200 Block of Sherman Avenue on March 9th. Officers located a 43 year old Oak Creek man and a 44 year old Racine man along with witnesses who broke up the argument. The Oak Creek man, who admitted driving the vehicle and appeared intoxicated, was arrested and issued citations for Operating While Intoxicated while the Racine man was given a verbal warning for his actions.
