

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *3/11/19 – 3/17/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **307** calls for service.

### **DISORDERLY CONDUCT**

Officers were dispatched to a report of subjects arguing in the 3600 Block of 9<sup>th</sup> Avenue on March 16<sup>th</sup>. Officers were met upon arrival by a 23 year old South Milwaukee woman who stated she had been arguing earlier with a 26 year old South Milwaukee man and had found items in her apartment damaged. Officers located the South Milwaukee man in the apartment and he was subsequently arrested. He was referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct-Domestic Violence Related and issued citations for Possession of Marijuana and Possession of Drug Paraphernalia.

Officers were dispatched to a report of a person refusing to leave a residence in the 2800 Block of South Chicago Avenue on March 16<sup>th</sup> and upon arrival located a 43 year old Cudahy woman. The woman, who was intoxicated, was yelling loudly and refusing to leave the area. After being warned and continuing to yell, the woman was arrested and issued a citation for Disorderly Conduct.

## **WARRANT ARREST**

**A 28 year old South Milwaukee man was arrested on a confirmed warrant with the Brown Deer Police Department following a traffic stop near Nicholson and Beech Avenues on March 15<sup>th</sup>. The man was taken to the police department where bond was posted on the warrant and he was issued a citation for Operating After Suspension. A 24 year old Milwaukee woman, who was a passenger and the vehicle's registered owner, was issued a citation for Permitting an Unauthorized Person to Drive.**

## **OPERATING WHILE INTOXICATED**

**Officers noticed a strong odor of marijuana coming from a vehicle on a traffic stop in the 400 Block of Marion Avenue on March 16<sup>th</sup> and the driver, a 17 year old Milwaukee boy, showed signs of impairment. He was arrested and issued citations for Operating Under the Influence-Drugs and Operating Without a Valid License. Another 17 year old Milwaukee boy who was a passenger in the vehicle, was issued citations for Possession of Marijuana, Possession of Drug Paraphernalia, and Littering after officers observed him throw marijuana from the vehicle prior to it stopping.**

**A 23 year old Milwaukee man was arrested and issued citations for Operating While Intoxicated following a traffic stop near North Chicago Avenue and Oak Creek Parkway on March 16<sup>th</sup>.**

**A 26 year old Oak Creek man was arrested and issued citations for Operating While Intoxicated and Failure to Stop at Stop Sign following a traffic stop near Nicholson and Milwaukee Avenues on March 12<sup>th</sup>.**
