

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *3/18/19 – 3/24/19***

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **291** calls for service.

### **DISORDERLY CONDUCT**

Officers were dispatched to a report of a 911 hang up call from the 3400 Block of South Chicago Avenue on March 19<sup>th</sup>. Upon arrival, officers located a 28 year old Greenfield man walking and drinking an intoxicant. The man admitted to placing the 911 call but stated he did not need any assistance. He was advised numerous times to dispose of the intoxicant and when he refused he was arrested and issued a citation for Possession of Intoxicants in Public.

A 45 year old South Milwaukee woman and a 39 year old Milwaukee man were arrested and issued citations for Possession of Marijuana, Possession of Drug Paraphernalia, and Contributing to the Delinquency of a Minor after officers were dispatched to a report of an underage party in the 1300 Block of Milwaukee Avenue on March 22<sup>nd</sup>. Officers also issued citations for Underage Possession of Intoxicants to two 18 year old South Milwaukee men, a 19 year old South Milwaukee man, a 19 year old Cudahy man, and a 20 year old Janesville man.

## **VEHICLE THEFT**

**A 37 year old South Milwaukee woman reported her 2005 Gray Chevrolet Silverado pick-up truck stolen from the 1200 Block of Missouri Avenue on March 22<sup>nd</sup>. A neighbor witnessed the truck leave the area being driven by an unidentified individual and an investigation is ongoing.**

## **RETAIL THEFT**

**Employees of a store in the 2900 Block of South Chicago Avenue reported a man ordered chicken at the deli and proceeded to eat it prior to paying for it on March 20th. When confronted, the man began to shout and threaten employees before leaving the store. Officers located the individual, a 38 year old Milwaukee man, in a nearby parking lot and he was arrested. Upon searching the man, an unpaid for bottle of liquor from the store was also located. The man was issued citations for Disorderly Conduct and Retail Theft.**

## **OPERATING WHILE INTOXICATED**

**A caller reported a possible intoxicated driver in a white van failing to stop at stop signs on March 24<sup>th</sup>. Officers located the vehicle near North Chicago Avenue and Walnut Street and conducted a traffic stop. The driver, a 51 year old Milwaukee man, showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility for referral to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-5<sup>th</sup> Offense.**

**An officer conducted a traffic stop on a vehicle with an inoperable brake light near South Chicago and Forest Hill Avenues on March 21<sup>st</sup>. Upon approaching the vehicle, the officer noticed a strong odor of marijuana. The driver, a 51 year old Racine man, admitted to smoking marijuana prior to driving. He was arrested and issued citations for Operating Under the Influence and Operating a Vehicle Without Stopping Lights.**
