

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 7/13/20 – 7/26/20**



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **561** calls for service.

### **DISORDERLY CONDUCT**

On July 25<sup>th</sup>, officers were dispatched to a report of a group of people arguing in the 300 Block of Marquette Avenue. Officers spoke with a 24-year-old South Milwaukee man, a 22-year-old South Milwaukee woman, and a 19-year-old Oak Creek woman who stated the Oak Creek woman was involved in a minor altercation with a 22-year-old Oak Creek man. The Oak Creek man was located at a nearby residence and he refused to speak with officers and continued to yell loudly. He was arrested and taken to the police station where he was issued citations for Disorderly Conduct and Obstructing before being turned over to a sober, responsible adult.

On July 22<sup>nd</sup>, officers were dispatched to the 1300 Block of Madison Avenue for a report of an individual refusing to leave a residence. Officers spoke with a 52-year-old South Milwaukee woman who stated a 51-year-old South Milwaukee man was intoxicated and refusing to leave her residence. After refusing numerous warnings to leave, the man was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

### **WARRANT ARREST**

On July 20<sup>th</sup>, officers were dispatched to a report of an occupied vehicle parked and running in the 1300 Block of Madison Avenue with the driver appearing to be passed out. Officers made contact with a 41-year-old Franklin man who was in the driver's seat sleeping. The man woke up and passed field sobriety tests but was found to have a confirmed warrant with the Greenfield Police Department. He was arrested on the warrant and taken to the police station where he signed a Personal Recognizance Bond.

## **DAMAGE TO PROPERTY**

On July 21<sup>ST</sup>, residents on Sherman, Blake, and Columbia Avenues reported damage to landscaping lights in yards. Officers located a 40-year-old Sacramento, California man in the 1200 Block of Columbia Avenue who matched the description given of a suspect. Officers viewed surveillance video from residents that depicted the man damaging the lights. He was arrested and taken to the police station where he was issued a citation for Criminal Damage to Property.

## **RETAIL THEFT**

On, July 22<sup>nd</sup>, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual in the store concealing items in a suitcase and leaving without paying for them. Officers located a 56-year-old Milwaukee man exiting the store with a suitcase containing the missing items. The man was found to have been banned from the business due to a previous retail theft arrest. The man also had a confirmed felony warrant for Retail Theft with the Milwaukee County Sheriff's Department. He was arrested and taken to the police station where he was issued citations for Retail Theft and Disorderly Conduct-Trespassing.

## **OPERATING WHILE INTOXICATED**

On July 13<sup>th</sup>, an officer on patrol initiated a traffic stop on a vehicle operating without taillights. The driver, a 32-year-old Milwaukee man, showed signs of impairment. Drug paraphernalia and a firearm were also located in the vehicle. The man was arrested and issued citations for Operating While Intoxicated-First Offense, Operating While Suspended, and Operating Without Taillights. He was taken to the Milwaukee County Criminal Justice Facility to be referred to the Milwaukee County District Attorney's Office on charges of Endangering Safety by Use of a Dangerous Weapon While Intoxicated and Threat to Law Enforcement Officers after making numerous threats toward officers.
