

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *9/7/20 – 9/20/20*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **467** calls for service.

OPERATING WHILE INTOXICATED

On September 11th, officers were dispatched to report of a vehicle striking a mailbox in the 700 Block of Edgewood Avenue before leaving the scene. The striking vehicle was located driving in the area and a traffic stop was initiated in near 6th and Edgewood Avenues. The driver, a 59-year-old South Milwaukee woman showed signs of impairment. She was arrested and taken to the police department where she was issued a citation for Operating While Intoxicated-First Offense before being released to a sober responsible adult.

On September 16th, an officer on patrol observed a vehicle traveling at a high rate of speed in the 1700 Block of Nicholson Avenue. The officer followed the vehicle and observed it deviate from the lane of traffic. A traffic stop was initiated near Drexel Boulevard and South Chicago Avenues. The driver, a 27-year-old Worcester, Massachusetts woman showed signs of impairment. She was arrested and taken to the police department where she was issued a citation for Operating While Intoxicated-First Offense before being released to a sober responsible adult.

On September 19th, officers were dispatched to a report of a parked car being struck in the 3700 Block of South Chicago Avenue with the driver of the striking vehicle leaving the scene on foot. Officers located a 22-year-old Greenfield woman who was identified as the driver of the striking vehicle. The woman showed signs of impairment and was arrested. She was referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-Second Offense.

RETAIL THEFT

On September 8th, officers were dispatched to a report of individuals leaving a business in the 200 Block of North Chicago Avenue without paying for items. Officers were advised the individuals left the scene in a vehicle after being confronted by store security. Officers located the vehicle on North Chicago Avenue and a traffic stop was initiated. The driver, a 23-year-old Milwaukee woman, and the passenger, a 24-year-old Milwaukee woman matched the description of the individuals that fled the business. The 24-year-old woman also had two confirmed warrants with the Brown Deer Police Department. She was issued a citation for Retail Theft and signed personal recognizance bonds on the warrants. The 23-year-old woman was issued citations for Operating After Suspension, Expired Registration, and Retail Theft.

On September 14th, officers were dispatched to a report of an individual leaving a business in the 2900 Block of South Chicago Avenue without paying for a rotisserie chicken. Officers located a 22-year-old Milwaukee man walking in the area who matched the description given. The man admitted to taking the chicken and he was issued a citation for Retail Theft.

On September 7th, officers were dispatched to a report of an individual leaving a business in the 2900 Block of South Chicago Avenue without paying for alcohol. Officers located a 50-year-old Milwaukee man who matched the description given. The man was in possession of the missing alcohol and did not have receipts for it. Surveillance video also confirmed he was inside the business. The man was also in possession of drug paraphernalia. He was issued citations for Retail Theft and Possession of Drug Paraphernalia.

On September 10th, officers were dispatched to a report of an individual attempting to leave a business in the 200 Block of North Chicago Avenue without paying for clothing items. Officers spoke with a 32-year-old Milwaukee woman who was being detained by store security. The clothing items were recovered and the woman was issued a citation for Retail Theft.
