

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *9/21/20 – 10/4/20***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **402** calls for service.

### **OPERATING WHILE INTOXICATED**

On October 4<sup>th</sup>, officers were dispatched to a report of a garbage truck driving erratically near Hawthorne Avenue and Lake Drive. Officers located the Milwaukee DPW truck and observed it deviate from the lane of traffic. A traffic stop was initiated near Park and North Chicago Avenues. The driver, a 27-year-old McCloud, Oklahoma man, did not have permission to operate the truck and showed signs of impairment. He was arrested and issued a citation for Operating While Intoxicated-First Offense before being turned over to officers from the Milwaukee Police Department on the theft of the truck.

### **HIT AND RUN ACCIDENT**

On September 30<sup>TH</sup>, a 22-year-old Kenosha man reported his vehicle was struck by a minivan while he attempted to make a turn at 10<sup>th</sup> and Minnesota Avenues. The minivan left the scene of the accident and other area agencies were notified of the incident. A short time later Milwaukee County Sheriff's deputies located the minivan and stopped it on I-43 near 68<sup>th</sup> Street. South Milwaukee officers responded to the scene of the stop and the driver, a 27-year-old West Allis man, admitted to being in the accident. He was issued a citation for Hit and Run and was arrested by the Milwaukee County Sheriff's deputies for Operating While Intoxicated.

**On September 28<sup>th</sup>, a citizen reported a vehicle struck several signs in the 800 Block of 15<sup>th</sup> Avenue and left the scene. Officers located signs knocked down and vehicle debris in the area. The citizen was able to provide the license plate number of the vehicle and it was located in the city of Oak Creek where a traffic stop was initiated by Oak Creek Police Department officers. The driver, a 35-year-old Racine man, was arrested by Oak Creek Police officers for Operating While Intoxicated-3<sup>rd</sup> Offense and was issued a citation for Hit and Run.**

## **ROBBERY**

**On September 28<sup>th</sup>, officers were dispatched to a report of an argument occurring in the 900 Block of Manitoba Avenue. Officers spoke with a 21-year-old South Milwaukee woman who stated that during the argument a 24-year-old Milwaukee man threatened her with a weapon and struck her while a 31-year-old Milwaukee woman took her purse. Officers were able to apprehend the man and he was arrested and referred to the Milwaukee County District Attorney's Office where he was charged with two counts of Robbery (Party to a Crime), and Domestic Violence related Battery and Disorderly Conduct. The 31-year-old Milwaukee woman is still being sought in connection with this incident.**

## **DISORDERLY CONDUCT**

**On October 4<sup>th</sup>, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of an individual acting disorderly. A 61-year-old Oak Creek woman told officers a 63-year-old Milwaukee man began shouting and using profanity towards her because she was at a gas pump the man wanted to use. Officers spoke with the man who admitted he was upset but denied directing the profanity towards the woman. He was issued a citation for Disorderly Conduct.**
