

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *11/16/20 – 11/29/20*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **418** calls for service.

DISORDERLY CONDUCT

On November 28th, officers were dispatched to the 900 Block of Monroe Avenue for a report of an intoxicated individual refusing to leave a business. Officers spoke with a 62-year-old South Milwaukee man who was uncooperative and refused to leave the business. He was arrested and taken to the police station where he was issued citations for Disorderly Conduct and Resisting Arrest.

On November 17th, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of a person being threatened. Officers spoke with a 69-year-old South Milwaukee woman who stated she observed a male and female arguing and when she verbally intervened out of concern for the female, the male party stated he had a weapon and threatened her. Officers located a 29-year-old Milwaukee man and a 26-year-old Milwaukee woman who matched the description of the individuals arguing. The two admitted to having a verbal argument and neither had any weapons. The man admitted he told the original caller he had a weapon when she spoke to him. The man was arrested and issued a citation for Disorderly Conduct. While investigating this incident, another individual claimed his cellphone and charger were stolen while he was inside a nearby business. Surveillance video showed the Milwaukee man take the phone and charger and he was also issued a citation for Theft.

On November 20th, officers were dispatched to a report of individuals involved in an altercation inside a vehicle parked in the 100 Block of Hawthorne Avenue. Officers spoke with a 20-year-old Greendale man and a 19-year-old Milwaukee woman. The man stated the woman began to strike him when he would not drive her where she wanted to go. The woman was uncooperative and continued to yell loudly despite being warned on her disorderly behavior. She was arrested and issued a citation for Disorderly Conduct.

SUSPICIOUS ACTIVITY

On November 29th, officers were dispatched to a report of a vehicle driving erratically that was now parked on the lawn of a residence in the 200 Block of Marshall Avenue. Officers spoke with a 41-year-old Monroe Center, Illinois man who was the driver of the vehicle and a 27-year-old Johnsburg, Illinois woman who was the passenger. Both individuals showed signs of impairment and drug paraphernalia was located in the vehicle. The man originally provided false identification and the woman began to yell loudly and both were arrested. The woman was issued a citation for Obstructing while the man was issued citations for Operating While Intoxicated, Operating Without a License, Operating a Motor Vehicle Without Insurance, Failure to Keep a Vehicle Under Control, Possession of Drug Paraphernalia, and Resisting Arrest. The man also had two open felony drug cases with Walworth and Kenosha Counties with a condition of bail being not to possess drugs or drug paraphernalia. He was also on Parole with the Illinois Department of Corrections and an Order to Detain was placed by Illinois Probation and Parole. The man was taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Felony Bail Jumping.

On November 20th, officers were dispatched to the 1800 Block of Missouri Avenue for a report of a suspicious parked and occupied vehicle. Officers located a 36-year old Oak Creek woman passed out on the grass near the vehicle and a 32-year-old Oak Creek man passed out in the rear of the vehicle. Both showed signs of impairment when awakened and the woman admitted to driving the vehicle. She was arrested and taken to the hospital for medical clearance by South Milwaukee Fire Department personnel. She was then taken to the police station where she was issued a citation for Operating While Intoxicated before being released to a sober responsible adult.
