

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *12/28/20 – 1/10/21***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **374** calls for service.

### **DISORDERLY CONDUCT**

On January 1<sup>st</sup>, officers were dispatched to a report of an argument at a residence in the 200 Block of Southtowne Drive. Officers spoke with a 30-year-old South Milwaukee woman and a 65-year-old South Milwaukee woman who stated a 25-year-old Cocoa, Florida man broke a window, threw items about the residence, and was involved in a physical altercation with them. The man was arrested and referred to the Milwaukee County District Attorney's Office where he was charged with Domestic Violence Battery and Disorderly Conduct-Domestic Violence Related.

On January 10<sup>th</sup>, officers were dispatched to the 1500 Block of Manitoba Avenue for a report of an argument. Officers spoke with a 38-year-old South Milwaukee man who stated a 43-year-old South Milwaukee woman threatened him with a knife. The knife was recovered and the woman admitted to brandishing it during the argument. She was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct While Armed.

On January 6<sup>th</sup>, officers were dispatched to a report of a woman being choked by a male at a residence in the 600 Block of Michigan Avenue. Officers eventually spoke with A 27-year-old South Milwaukee woman and a 34-year-old Cudahy man who were involved in the argument. Both were arrested and referred to the Milwaukee County District Attorney's Office on charges of Domestic Violence Strangulation and Suffocation for the man and Disorderly Conduct While Armed for the woman after it was determined the man received a minor cut from a knife during the altercation.

## **DRUG INVESTIGATION**

On December 30<sup>th</sup>, officers were dispatched to a report of possible drug activity involving a suspicious vehicle in the 2300 Block of 10<sup>th</sup> Avenue. Officers located the vehicle and spoke with an 18-year-old Cudahy woman and a 25-year-old Oak Creek man. The man was wanted by the West Allis Police Department on an unrelated incident and the woman had a confirmed warrant with the South Milwaukee Police Department. Both were arrested and drug paraphernalia and illegal controlled substances were located in the vehicle. The woman signed a Personal Recognizance Bond on the warrant and the man was issued citations for Operating Without a License, Possession of Marijuana, Possession of Drug Paraphernalia-Marijuana, Possession of Drug Paraphernalia-Cocaine, and Possession of Drug Paraphernalia-Heroin. He was also referred to the Milwaukee County District Attorney's Office on charges of Felony Bail Jumping, Possession of Amphetamines, and Possession of Controlled Substances.

## **OPERATING WHILE INTOXICATED**

On January 3<sup>rd</sup>, an officer on patrol initiated a traffic stop on a vehicle operating without headlights in the 3000 Block of South Chicago. While speaking with the driver, a 23-year-old Milwaukee man, the officer detected a strong odor of marijuana. The man admitted to smoking marijuana prior to driving and showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Under the Influence-First Offense and Operating While Suspended. He was released to a sober responsible adult.

## **RETAIL THEFT**

On January 7<sup>th</sup>, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of individuals attempting to leave the store without paying for items. Store security had detained a 22-year-old Milwaukee woman and a 24-year-old Milwaukee man who used coats to conceal energy drinks that were not paid for. Both were issued citations for Retail Theft.
