

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *1/11/21 – 1/24/21***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **396** calls for service.

### **OPERATING WHILE INTOXICATED**

On January 22<sup>ND</sup>, officers were dispatched to the 2400 Block of 5<sup>th</sup> Avenue for a report of a hit and run accident. Officers located a parked vehicle with severe damage facing the wrong way in the road which witnesses stated was struck by a black truck that left the scene. The damaged truck was located near 4<sup>th</sup> and Marquette Avenues and the driver, a 38-year-old Oak Creek woman, showed signs of impairment. She was arrested and taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-3<sup>rd</sup> Offense and Operating with a Prohibited Blood-Alcohol Concentration-3<sup>rd</sup> Offense.

On January 23<sup>rd</sup>, an officer on patrol observed a vehicle travel through a flashing red traffic signal at 17<sup>th</sup> and Rawson Avenues without stopping and a traffic stop was initiated. The driver, a 23-year-old Cudahy man, showed signs of impairment and was found to have a confirmed warrant. He was taken to the police station where he was issued citations for Operating While Intoxicated-First Offense, Operating with a Prohibited Blood-Alcohol Concentration-First Offense, Operating While Suspended, and Failure to Stop at a Flashing Red traffic signal. He signed a Personal Recognizance Bond on the warrant and was released to a sober, responsible adult.

On January 17<sup>th</sup>, an officer initiated a traffic stop on a vehicle near 7<sup>th</sup> and Marquette Avenues after observing it travel in the wrong traffic lane and nearly strike a parked vehicle. A citizen caller also reported the vehicle driving recklessly. The driver, a 22-year-old Milwaukee man, showed signs of impairment. He was arrested and issued citations for Operating While Intoxicated-First Offense, Operating After Revocation, Reckless Driving, and Possession of Marijuana.

## **DISORDERLY CONDUCT**

**On January 15<sup>th</sup>, officers were dispatched to the area of 15<sup>th</sup> Avenue and Drexel Boulevard for a report of an altercation between two individuals who were involved in a road-rage type incident. Officers spoke with a 38-year-old South Milwaukee woman and a 30-year-old South Milwaukee woman. Witnesses on the scene stated after parking their vehicles and arguing the 30-year-old woman struck the 38-year-old woman numerous times. The 30-year-old woman was arrested and issued a citation for Battery.**

**On January 16<sup>th</sup>, officers were dispatched to a business in the 2300 Block of 10<sup>th</sup> Avenue for a report of an individual that was refusing to leave the store. Officers spoke with a 29-year-old Milwaukee man who was intoxicated. The man continued to shout loudly and was uncooperative despite being told numerous times to leave the business. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.**

**On January 23<sup>rd</sup>, officers were dispatched to the 200 Block of Southtowne Drive for a report of an individual causing problems and refusing to leave a residence. Officers spoke with a 65-year-old South Milwaukee woman and a 30-year-old South Milwaukee woman who stated a 25-year-old Cocoa, Florida man threw numerous items about the residence and damaged a door. The Florida man was also found to have a No Contact order with the 30-year-old woman. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being charged by the Milwaukee County District Attorney's Office with Disorderly Conduct-Domestic Violence Related and Bail Jumping.**

## **WARRANT ARREST**

**On January 19<sup>th</sup>, the Cudahy Police Department requested mutual aid assistance in locating an individual bothering customers at a restaurant and refusing to leave. Officers located and spoke with a 30-year-old Milwaukee man who was found to have a confirmed warrant with the Milwaukee County Sheriff's Office. He was arrested on the warrant and taken to the police station where he was turned over to Milwaukee County Sheriff's Office deputies.**
