LETTER FROM THE ADMINISTRATION AND SERVICES COMMANDER

In 2017, the SMPD communications center logged over 28,000 events. The dispatchers are responsible for all incoming calls to the SMPD, radio transmissions for the police and fire, and handling 911 emergency calls. The SMPD does not provide pre-arrival medical instructions but all dispatchers are trained to recognize when an emergency call requires the assistance of CPR being administered. Dispatch will transfer 911 callers to a special operator at the Milwaukee County EMS Communications Center for assistance after first dispatching EMS to the call. The CPR Assist Line helps callers perform CPR until EMS arrives on scene. In 2017, the SMPD switched over to a digital radio system which greatly improved radio quality.

The Records Department is supervised by IT Specialist Dan Margetta who oversees two records clerks. The records section is open Monday through Friday from 7am-8pm and closed on weekends and holidays. The records section handles records requests, winter parking permits, and collection of payments. A request for records can be found on our website.

The Internal Affairs section investigated very few citizen complaints in 2017 which is a credit to the members of the SMPD.

As Wisconsin Law Enforcement Accreditation Group (WILEAG) assessors, Chief Ann Wellens, Capt. Jill Kallay, and I continue to assist other agencies with helping them achieve their WILEAG status while continuing to work hard on maintaining our own WILEAG status.

LETTER FROM THE OPERATIONS COMMANDER

The year 2017 brought us another new officer to the Police Department. We hired and welcomed Officer Matthew Kramer to our department in August and he began the police academy shortly after. Officer Daniel Fournier was promoted to Lieutenant and assumed Command of the Late Shift in August, 2017.

The City continued to be busy with numerous special events and activities that required planning for scheduling and staffing. Although these events appear to go off seamlessly to the public they require a lot of work on the part of the police department. Events like the Little League parade, July 4th festivities and the week-long Heritage Days events, as well as the many other special events and activities that take place in and through our City, continue to be busy ones for the police department to plan and staff. Day to day scheduling for patrol for the department this year was a little better due to less shortages than last year. We continue to have a number of dedicated officers on the department who work numerous overtime shifts to help cover any patrol shortages across shifts as well as to provide coverage for any and all special events as well as to work specialty grant programs. I continue to be very thankful for all of the hard work that our officers put in every day.

I continued to work on department training in 2017. During the year we held three 8 hour in-house in-service training days to cover a variety of topics. All officers were recertified in CPR in 2017. We continued training on ALERRT (Advanced Law Enforcement Rapid Response Training). We also covered vehicle contacts training, firearms trainings and defense and arrest tactics training. Officers also attended various specialty trainings outside of the department on many different topics. The department will work to continue to provide quality training and work to always provide updated

equipment for officers so that we may continue to do their jobs in the safest and best way possible for everyone.

I again use this opportunity to remind our citizens to be proactive in the prevention of crime. Use crime preventative lighting outside your home. Keep your home, garage and car doors locked. Be vigilant. Look out for your neighbors and yourselves.

Public Safety Officer Aaron Hemman





The Police Department is made up of 33 sworn officers, 2 clerks, 1 part-time clerk, 4 public safety officers, and 2 part-time public safety officers. Of the 33 sworn officers, 7 officers are command officers, 6 officers are assigned to the third shift, 7 officers are assigned to the day shift, 8 officers are assigned to the second shift, and 5 officers are assigned to the Investigations Section.

INVESTIGATIONS SECTION

Dear Citizens,

The Investigations Section has two Investigators assigned to conduct general investigations: Investigator Carol Olson, assigned to the day shift and Investigator Jonathan Rivamonte who is assigned to early shift. The general investigators conduct a broad array of mostly felony cases such as drugs, theft, forgery, and burglary, to violent crimes like robbery, sexual assault, and homicide. The general investigators are also charged with conducting pre-employment background investigations for our sworn and non-sworn personnel prior to a job offer.

We have two Police School Liaison/Juvenile Officers: Officer David Kozlowski, who works primarily at the high school, and Officer James McLean, who works primarily at the middle school. These officers spend most of their work days in the schools during regular school days. They also conduct a number of investigations into child neglect, as well as cases involving the physical and sexual abuse of children.

The Investigations Section has an Investigator assigned full-time to the Milwaukee Metropolitan Drug Enforcement Group, a multi-jurisdictional task force charged with conducting major level drug investigations in the Milwaukee area. Officer Craig Perkowski completed his service in that unit and was replaced by Officer Logan Staege. The officer assigned to this unit and other members of the unit will frequently assist the South Milwaukee Police Department with investigations both in and outside of our city, as well as conducting narcotics search warrants. Drug abuse is so deeply entwined with all other types of crime, every officer in the investigations section will work on drug related cases throughout the year.

These assignments within the Investigations Section are temporary in nature, lasting three to five years. This allows for a well-rounded and experienced officer who is able to take complex cases from start to finish. The Investigators also present cases to the District Attorney's Office, testify in court, transport evidence to the crime lab and assist patrol officers with their follow-up investigations.

New this year is our entrance into a multi-jurisdictional investigative team which investigates officer involved critical incidents. The officers assigned to this unit are available to assist in investigations, within other jurisdictions, of law enforcement incidents that result in the death or serious injury of a citizen. This type of investigation is mandated by state law, and is done to conduct an impartial investigation, providing a report to the District Attorney who will decide whether or not charges may need to be brought against an officer for their actions.

In 2017, South Milwaukee experienced a decrease in property crimes. Violent crime reports also decreased. Property crime decreases are due to the decreases in all categories. Violent crime decreases are due to decreases in aggravated battery and robbery.

During 2017, the total number of people held in the lockup increased from 217 to 242. Of these detentions, 186 were males and 56 were females. Not all people arrested are placed in the Municipal Lockup. Some are immediately transported to the Milwaukee County Criminal Justice Facility or turned over to another agency. Those that are held may also be released on their own recognizance, held for a 12 hour municipal OWI charge, or released after bond is posted for a municipal commitment or warrant.


There were 352 reported thefts in South Milwaukee in 2017 compared with 398 reported thefts in 2016. The average amount taken decreased from \$491 in 2016 to \$425 in 2017. The total dollar loss decreased from \$195,289 in 2016 to \$149,735 in 2017.

CRIMES AGAINST PUBLIC PEACE

In 2017, SMPD responded to a total of 264 animal related calls/complaints, down 17.2% from 2016. These calls include Animal Noise calls as well as Animal at Large complaints and Animal Bite complaints.

There were 670 Disorderly Conduct incidents reported in 2017, an increase of 4.2% from 2016. Disorderly Conduct is defined by state statute as conduct that occurs in a “public or private place” and is “violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly.” The fine for municipal Disorderly Conduct is \$439.00. It can also be charged as a state ‘Class B’ misdemeanor criminal offense.

South Milwaukee Police responded to 294 Noise complaints in 2017, down 9.0% from 2016. These complaints range from loud music complaints to reports of people yelling and/or loud parties. The fine for Unnecessary Noise is \$187.00.

Included in the duties of law enforcement officers is traffic law enforcement. During 2017, the Department continued the directed traffic enforcement program. Each week, locations within the city were highlighted for directed enforcement. The areas are selected based on accident statistics, citizen complaints, requests of the Traffic Commission, or high traffic areas. Using grant money from the Bureau of Transportation Safety, the Department, once again, participated as a member of the OWI Task Force and in conducting specialized, limited speed enforcement activities. The Department utilizes several radar and laser speed measuring devices in the enforcement efforts. An increase in traffic grant funds resulted in an increase in the ability for officers to spend time solely on traffic enforcement.

* OWIs often result in two traffic citations issued, one for Driving Under the Influence and one for a Prohibited Alcohol Concentration. The court system has the authority to dismiss one of the two citations issued during an OWI incident.

2017 statistics include 111 written warnings issued for various traffic violations. There were 3,231 parking citations issued during 2017.



The goal of the South Milwaukee Police Department is to provide a high standard of professional services. Patrol Officers handle calls that range from domestic problems, neighbor problems, noise violations, park violations, to suicidal persons and robberies. Patrol Officers are responsible for the initial investigation of all calls. Patrol Officers are also responsible for traffic enforcement, accident investigations, business checks, and many other duties.

- Total calls for service for 2017 was 25,263. Calls for service decreased when compared to 2016 (25,545)
- Calls for service include EMS and Fire services, but do not include non-service type calls such as court trials, DARE duties, report writing, and crime prevention duties.

2017 SOUTH SHORE JOINT TACTICAL UNIT

The South Shore Joint Tactical Unit is comprised of 34 officers and firefighters from South Milwaukee, St. Francis and Cudahy PD's and FD's. Our departments have a memorandum of understanding that allows us to operate as a joint team. This allows for training in advanced tactical techniques, sharing the costs of training or incident management, having a larger pool of personnel to draw from in the event of an incident, and increasing our knowledge base with the varied experiences of our members. In addition, we are able to draw upon other resources throughout the area to help incidents come to a peaceful resolution while ensuring the safety of our officers and citizens.

We serve warrants within our own jurisdictions and beyond depending on where an investigation leads us, as well as working with other agencies throughout Milwaukee County when multiple warrants need to be served simultaneously. This year we served a total of 12 search warrants for narcotics, felony arrest warrants and assisted with three federal papers. There were, thankfully, no barricade or hostage related incidents this year.

Professionalism is important to us, and we are always looking to improve. We follow the standards put forth by the National Tactical Officers Association for a unit of our size. One of the things we have done to help improve public safety is start up a sniper team this year. One of our officers had been a sniper with the Milwaukee County Sheriff's Office, and another completed the required schooling.

Another thing that we do to improve is conduct a yearly operational evaluation, asking other entities to critique our performance. There is a lot of coordination required to conduct this: locations need to be identified and permission gained to use them, role players are solicited to help, the correct munitions need to be available, tactical vehicles need to be procured and our evaluators need to be identified, just to name a few things. This year, the FBI agreed to help us in that regard, giving us suggestions to help improve our operations. We are grateful for their input and have done the same for other teams. Our bi-monthly training helps to keep our skills sharp. Because we are not a full-time team and our members are comprised of officers from all shifts, our experience is on the road in our communities 24/7. This translates into safer communities by having these experienced officers resolve situations before they rise to a level where SWAT may have been called in the past.

ACCREDITATION



The South Milwaukee Police Department continues its membership in the Wisconsin Law Enforcement Accreditation Group (WILEAG). This program is a continuous process enabling law enforcement agencies to evaluate, strengthen, improve and maintain their effectiveness. It works on a process of self-evaluation, keeps in check law enforcement activities, procedures and goals. It also ensures the condition of law enforcement agencies remain in compliance with established standards. The SMPD has been accredited through WILEAG since May 1998 and was one of the first agencies in Wisconsin to become accredited.

The accreditation process requires the Department to have numerous policies in place and several standards met. When changes in the standards are made by the WILEAG the existing policies need to be reviewed and revised to reflect any necessary changes. This requires a continuous review of all department functions and operations.

Accreditation offers the South Milwaukee Police Department several benefits: providing "norms" against which agency performance can be monitored and measured over time; increased cooperation and coordination with other law enforcement agencies; increased effectiveness and efficiency in the delivery of law enforcement services; and demonstrating to the community that the SMPD is committed to continuing these standards through accreditation.

In 2017, the SMPD was the first agency in the state to be awarded re-accreditation status using the 5th Edition WILEAG standards.
