Government Services:

The City of South Milwaukee has a Mayor and an eight member Common Council. The Police Department is made up of 33 sworn officers, 2 clerks, 1 part-time clerk, 4 public safety officers, and 2 part-time public service officers. Of the 33 sworn officers, 7 are command officers, 6 are assigned to the third shift, 6 are assigned to the day shift, 9 are assigned to the second shift, and 5 are assigned to the Investigations Section.

LETTER FROM THE CHIEF

The men and women of the South Milwaukee Police Department are proud to present our Annual Report for 2012. This document reflects the activities of the department members.

The data found in this annual report represents only a snapshot of the total activities of the South Milwaukee Police Department over the past year. The Department has implemented many new programs and continues to strive to provide excellent opportunities for working with our citizens regarding local concerns.

In 2012 the Department experienced several personnel changes. Officer Scott Komorowski retired from the Department after 28 ½ years of service to our community. Public Safety Officer Yvonne Wozniak retired from the Department after 22 ½ years of service to our community. We thank them for their dedication and commitment to the citizens of South Milwaukee. Officers Steve Martin and Jared Manthe resigned from the Department. The Department also experienced interdepartmental transfers. Public Safety Officer Karla Immel transferred to the Treasurer's Office, and Clerk Danielle Heller transferred from the City Clerk's Office to the Police Department. Internally Clerk Candy Maxium transferred from the Department's Records Section to the Communication Center as a Public Safety Officer. Public Safety Officer Debbie Benkowski, Officer Dan Doering and Officer Chris Rohde were hired by the Department. In November Officer Nathan Siefert began his assignment as a Police School Liaison Officer assigned to the Middle School.

In 2012 the Department implemented a "paperless" report system. This new system no longer required the Department to print every police report. The reports are stored electronically on the Department's server.

The Department also partnered with the Wisconsin Department of Justice – Wisconsin Crime Alert Network (WCAN). WCAN is a statewide program that links law enforcement agencies with the business community and the public in a partnership to fight crime. This program is a highly effective program which can help to prevent crime, find stolen property, locate missing persons, identify suspects and locate fugitives. WCAN allows law enforcement agencies to send out crime alert bulletins rapidly, to the business community and to the general public, whenever a crime or suspect may affect citizens or businesses. Citizens and businesses can sign up on the WCAN website: www.wisconsincrimealert.gov.

The Department also received a very generous donation from the South Shore Mason Lodge No.3 to provide tactical medical kits to every officer on the Department. An article on the donation is located within the annual report.

One disappointment of 2012 was canceling the Bicycle Safety Program and the D.A.R.E. Golf Outing. Due to manpower shortages both of these popular events had to be postponed.

The Police Department continued our successful Medicine Collection Program. The Department collected and safely disposed of 494 pounds of medication in 2012, up 336 pounds since 2011. The Department also installed a medicine collection box in the lobby of the Police Department. The collection box is available 24 hours a day/7 days a week and provides a more convenient method for citizens to properly dispose of medication. Zindovie Motors, of South Milwaukee, donated their services by painting the exterior of the box.

Dispatch consolidation conversations continued between the cities of St. Francis, Cudahy and South Milwaukee. The over-site Committee met several times and the conversations and research continued into 2013.

In 2012 the Department welcomed Pastor Robert Kieck as the Police Department Chaplain. Pastor Kieck has strong ties to the City of South Milwaukee and is a wonderful addition to the services the Police Department provides to our community. Chaplain Kieck has been trained to help victim(s) and family member(s) deal with crisis situations such as fatal crashes, sudden death events, death notifications, and other crisis events.

The cities of South Milwaukee, St. Francis, and Cudahy Police Departments signed a MOU for a joint South Shore Tactical Team. This combined team was established with the primary goal of providing specialized police services in critical incidents which require a response beyond the scope of the normal operational protocol and control of each of the individual agencies. The team members had been training together for over two years.

Once again the Police Department in partnership with the South Milwaukee High School, Advance Marketing Class, sponsored a "Justice for a Cure" Day in South Milwaukee. The partnership included several special events at the public schools. This joint effort raised \$10,744.23 for the Susan G. Komen Foundation.

The members of the South Milwaukee Police Department, working cooperatively with our citizens and elected officials, have met many difficult challenges during the past year. We have also implemented many innovative programs in an effort to increase the efficiency and effectiveness of the Department. The future holds many new and different challenges. I am sure we will meet those challenges with the support of the community and our elected officials.

On behalf of the members of the South Milwaukee Police, I extend my personal appreciation for the support and cooperation the citizens and elected officials have provided the Department. Together, we are making a difference in South Milwaukee.

Letter from the Administration and Services Commander

As Administration and Services Commander my areas of supervision include Records, Dispatch, Policy review/revision, Internal Affairs and Accreditation Management.

The Records Department had a change in personnel due to a transfer of our night time records clerk, Candace Maxim to full time Dispatch. We added a new records clerk, Danielle Heller. The Records Department continues to work efficiently to process records requests quickly. As technology increases, so does their workloads. They handle a large number of lobby customers for winter parking permits as well as citation payments and police calls for service. They work hard to provide high levels of customer service and the many demands placed on them. The Records Department is made up of Shannon LeDuc, Dan Margetta and Danielle Heller.

In the area of Information Technology our IT Specialist, Dan Margetta, was again challenged with keeping up with the technology changes and trouble-shooting any and all issues with technology. Squad car video issues meant a lot of time trying to work through the systems to ascertain the problem. Dan works hard to try to keep things up and running. New Criminal Justice Information Systems (CJIS) security requirements meant compliance had to be met for access to these important systems by the end of 2012. Dan also worked to ensure all aspects had been met.

The Dispatch Center was hit hard this year with a retirement and the transfer of a full timer to another City department. Our remaining dispatchers worked many shifts of overtime to see that shifts were filled and that our new addition, Debbie Benkowski, was trained. Our 2nd shift veteran, Jesse Danek, had primary responsibility for the training of the new dispatcher. I was grateful that Candace Maxim returned to the Dispatch center as a full time 3rd shift dispatcher this year to fill one of the full time shortages. . Dispatchers handled 26,764 dispatched events in 2012. Dispatchers monitor all radio traffic and answer all administrative as well as emergency phone calls. They are a very hard working group of people. The Dispatcher Center includes dispatchers Mary Horn, Roberta Plachinski, Jesse Danek, Candace Maxim, Jennifer Guzman-Godoy and Deborah Benkowski. Retired PSO Yvonne Wozniak was also added back as a part-time dispatcher to assist with coverage of the Dispatch Center when needed.

On the Internal Affairs side of the Administration position, there were a few minor complaints received in 2012 and a few policy violations resulting in reprimands.

The department was re-accredited by the Wisconsin Law Enforcement Accreditation Group (WILEAG) in 2011. Our next on-site assessment will be in 2014. WILEAG recently approved new 4th Edition standards which we will be working to comply with.

The major incidents from 2012 were fatal crashes, and the tragedy in Oak Creek . The crashes all involved some type of substance abuse and serve as a reminder that lives are at stake in our battle against impaired driving. The tragedy in Oak Creek reminds us that the truly horrific events, normally seen on TV, can happen here, and we need to be ready.

Crime trends and quality of life issues within the community appear steady, but we must continue to identify problems, and take decisive action before things get out of hand. We must use our resources efficiently and strive to do more.


Daniel Doering

The primary responsibilities of the dayshift patrol are to respond to various calls for service and maintaining consistent enforcement of traffic and criminal laws. Additional duties for these officers are performing directed patrols at the beginning and end of school days at the various schools throughout the city. This crime prevention technique enables officers to be more visible around the beginning of the school day and at dismissal times to prevent school violence in and around the schools, loitering, vandalism, and suspicious persons from approaching students. Dayshift is also responsible for bringing cases down to the Milwaukee County District Attorney's Office, meeting with the Milwaukee County Community Prosecutor at the Department to go over state cases, and as a liaison with Probation & Parole which holds office hours several days a week at the SMPD. Investigations Section

Dear Citizens,

It is my pleasure to continue to serve the city as the supervisor of our Investigations Section. The investigations section of the South Milwaukee Police Department consists of the following personnel:

The Investigations Section has two Investigators assigned to conduct general investigations. Investigator Steven Hesse, assigned to the dayshift and Investigator Michael Hill who is assigned to second shift. The general investigators conduct a broad array of mostly felony cases such as theft, forgery, and burglary, to violent crimes like robbery, sexual assault, and homicide. The general investigators are also charged with conducting pre-employment background investigations for our sworn and non-sworn personnel when they are hired.

The Investigations Section has two Police School Liaison/Juvenile Officers, Officer Timothy Lewison, who works primarily at the high school, and Officer Siefert, who works primarily at the middle school. These officers spend most of their work days in the schools during regular school days. They also conduct a number of investigations into child neglect, as well as cases involving the physical and sexual abuse of children.

The Investigations Section has an Investigator assigned full-time to the Milwaukee Metropolitan Drug Enforcement Group, a multi-jurisdictional task force charged with conducting major level drug investigations in the Milwaukee area. The officer assigned to this unit and other members of the unit will frequently assist the South Milwaukee Police Department with investigations both in and outside of our city. Drug abuse is so deeply entwined with all other types of crime, every officer in the investigations section will work on drug related cases throughout the year.

All assignments to investigations positions are temporary per the labor agreement with the officers. 2012 saw Officer Siefert replace Officer David Kozlowski as a Juvenile Officer.

Some significant cases brought to prosecutions in 2012 were a series of two liquor store robberies in March. The offender in that case was also found to have committed robberies in Oak Creek and Cudahy. Our Investigators were instrumental in stopping another serial armed robber in June and July of 2012 after he and at least one accomplice had robbed a liquor store in our city as well as liquor stores and fast food restaurants in West Allis and Wauwatosa. We were able to catch a serial, daytime burglar, who was arrested for striking at least five residences in our city as well as many from other jurisdictions as well. Our officer assigned to the drug unit was recognized by the supervisor in that group for outstanding work in a large scale Heroin case. This is just a few of the many cases we worked on.

Our clearance rates were on the rise in 2010 and 2011, which is a trend that carried into 2012. We will work hard to continue this in 2013.

In 2012, South Milwaukee experienced a decrease in property crimes. Violent crime reports increased. Property crime decreases are due, primarily, to the decrease in thefts. Violent crimes increases are due, primarily to a substantial increase in Aggravated Battery calls.



During 2012, the total number of people held in the lockup increased from 252 to 310. Of these detentions, 248 were males and 62 were females.

Not all people arrested are placed in the Municipal Lockup. Some are immediately transported to the Criminal Justice Facility or turned over to another agency. Those that are held may also be released on their own recognizance, held for a 12 hour municipal OWI charge, or released after bond is posted for a municipal commitment or warrant.



2012 Burglaries and Thefts

There were 76 burglaries in 2012 compared to 77 burglaries in 2011. The average amount taken in a burglary decreased from \$1,259 in 2011 to \$1,076 in 2012. The total amount taken in burglaries decreased from \$96,922 in 2011 to \$81,789 in 2012.

There were 354 reported thefts in South Milwaukee in 2012 compared with 410 reported thefts in 2011. The average amount taken in 2012 increased to \$450 from \$315 in 2011. The total dollar loss in 2012 increased to \$159,244 from \$129,184 in 2011.


Crimes Against Public Peace

Disorderly Conduct / Animal / Noise

In 2012, SMPD responded to a total of **314** animal related calls/complaints, up 4.5% from 2011. These calls include Animal Noise calls as well as Animal at Large complaints and Animal Bite complaints.

There were **683** Disorderly Conduct incidents reported in 2012, a decrease of 1.2% from 2011. Disorderly Conduct is defined by state statute as conduct that occurs in a “public or private place” and is “violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly.” The fine for municipal Disorderly Conduct is \$169.00. It can also be charged as a state misdemeanor criminal offense.

South Milwaukee Police responded to **413** Noise complaints in 2012, up 5.3% from 2011. These complaints range from loud music complaints to reports of people yelling and/or loud parties. The fine for Unnecessary Noise is \$169.00.



2012 Traffic Enforcement

Included in the duties of law enforcement officers is traffic law enforcement. During 2012, the Department continued the directed traffic enforcement program. Each week, locations within the city were highlighted for directed enforcement. The areas are selected based on accident statistics, citizen complaints, requests of the Traffic Commission, or high traffic areas. Using grant money from the Bureau of Transportation Safety, the Department, once again, participated as a member of the OWI Task Force and in conducting specialized speed and seatbelt enforcement activities. The Department utilizes several radar and laser speed measuring devices in the enforcement efforts.

* OWIs often result in two traffic citations issued, one for Driving Under the Influence and one for a Prohibited Alcohol Concentration. The court system has the authority to dismiss one of the two citations issued during an OWI incident.

2012 statistics include **125** written warnings issued for various traffic violations.

The total number of traffic citations/warnings issued in 2012 was **3,121**. This is approximately 1,400 more traffic citations than last year. This was based largely on the increase in speed and seatbelt violations in 2012.

There were **3,972** parking citations issued in 2012.

Police Awards Night 2012

The week of May 13-19, 2012 was designated as National Peace Officers Week. In conjunction with National Peace Officers Week the Police Department held the annual Department Awards to recognize selected staff and citizens from the community.

On Tuesday, May 15th five officers from the Police Department and seven citizens were presented Police Department Awards at the Common Council meeting. Mayor Zepecki kindly allowed time at the beginning of the meeting for the Department presentation. The following officers and citizens received the following awards:

LIFE-SAVING COMMENDATION: Awarded to an officer whose action directly contributed to the saving or significant prolonging of human life.

Officer Kyle Stormoen and Officer Vinohradsky: Nominated by Officer Siefert

On October 10, 2011 Officer Stormoen and Officer Vinohradsky responded to a possible Chapter 51. A citizen reported a subject who appeared to be jumping into the falls at Mill Rd. Officers Stormoen and Vinohradsky located a subject sitting on the top railing of the bridge leaning into the waterfall on Mill Rd. Officer Stormoen recognized the subject from a prior Chapter 51 call (exact same location 6 months prior). Officer Stormoen engaged the subject in conversation, while Officer Vinohradsky approached the subject from behind, and pulled him off the railing to safety. Based on the subject's previous mental health history and his current state of mind – Officers Stormoen and Vinohradsky's quick thinking and actions saved his life.

MERIT AWARD: Awarded for excellent arrest by any officer directly involved in the capture and arrest of a felon who was endangering the lives and/or property of the community.

Lt. Chad Milow and Officer Nathan Siefert: Nominated by Lt. Cary Fischer

On October 11, 2011 Officer Siefert investigated a subject who was walking near the Police Department who appeared suspicious. This subject entered a yard enclosed by a fence that Officer Siefert knew the residence did not have teenage children. Upon making contact with the subject Officer Siefert recognized the subject as a local runaway. Officer Siefert located on this subject property that was suspicious. Through his investigation Officer Siefert determined the property was from a burglary that occurred earlier in the day. Lt. Milow assisted Officer Siefert in the investigation and obtained a confession from the subject regarding the burglary. The subject was arrested and referred to Children's Court where he was charged with the crime of burglary. Based on Officer Siefert's observations and investigation of a suspicious person a burglary was solved and property was returned to the owner. Without Officer Siefert and Lt. Milow's actions this crime may have not been cleared by arrest.

SUPERVISOR'S RECOGNITION AWARD: Committee approval, for outstanding work.

A supervisor may give this award, without Awards

Officer Steve Streicher:

Lt. Jaske recommended Officer Streicher for a Supervisor's Recognition Award for his investigation of a substantial contractor fraud case (\$73,000.00).

CITIZEN RECOGNITION AWARD:

Whenever any officer believes that behavior coming to the attention personally or through a third party is deserving of recognition by the Department, an officer should indicate the circumstances of the incident in writing and should forward same to the Awards Committee. Upon Committee approval, the Chief will affix their stamp of approval.

Mr. David Acevedo & Mr. Reinaldo Acevedo:

Officer Carol Olson recommended Mr. David Acevedo and Mr. Reinaldo Acevedo for a Citizen Recognition Award for their action on November 7, 2011.

On November 7, 2011 David and Reinaldo were traveling in a vehicle on 6th Avenue when they observed smoke coming from a residence on 6th Avenue. David immediately pulled over the vehicle and told his wife to call 911. David and Reinaldo went to the residence and began knocking on the doors in an attempt to notify the occupants of a potential fire. Because of their actions one family that was sleeping in one of the units was awakened and was able to safely exit the burning building. David and Reinaldo's actions as concerned citizens on November 7, 2011 resulted in the family safely exiting the burning residence.

Mr. Randy Brandt, Mrs. Christine Brandt & Ms. Randi Brandt:

Lt. Milow recommended the Brandt family for a Citizen Recognition Award for their action on November 11, 2011.

On November 11, 2011 the Brandt family noticed unusual activity at their neighbor's residence. They were aware their neighbors were out of town and no one should be at the residence. Mr. Brandt confronted a youth in his neighbor's yard and detained him until officers could arrive. Mrs. Brant observed a vehicle leaving the residence and reported that information to the officers. Mrs. Brant also detained several youth located inside the neighbor's residence. Through an investigation it was learned several youths had been hanging out at their neighbor's residence while the neighbors were out of town. Several youths were arrested, and either received municipal citations or were referred to Children's Court for charges.

Because the Brandt family was willing to get involved and be a good neighbor they assisted in protecting their neighbor's property. Without their assistance this crime would have possibly gone unsolved. It is wonderful when our neighbors look out for each other.

Mr. Joseph DeLong:

Officer Mick Olson recommended Mr. DeLong for a Citizen Recognition Award for his action on February 17, 2012.

On February 17, 2012 Mr. DeLong was working as a United States Postal Carrier in the City of South Milwaukee. While on his route Mr. DeLong observed three days of accumulated mail at a residence. He felt this was unusual and notified his supervisor who then contacted SMPD. Officers responded to the residence, forced entry into the residence under the community care taker role and located an elderly home owner on the floor of the residence. The owner had fallen three days earlier and was unable to get up. Because of Mr. DeLong's actions this individual was able to get help when he needed it the most.

Although the Police Department has been called to residences by mail carriers in the past, this was the first time a resident was found in duress. Mr. DeLong's actions saved the resident's life.

Mr. Jeffrey Hatzenbeller:

Captain Jill Kallay recommended Mr. Hatzenbeller for a Citizen Recognition Award for his action on March 24, 2012.

On March 24, 2012 Mr. Hatzenbeller was driving through town when he observed several officers in a foot pursuit with a subject. After observing this action Mr. Hatzenbeller began following the subject in his vehicle monitoring where the subject was running. At one point Mr. Hatzenbeller advised Captain Kallay, who had been on foot pursuing the subject, where the subject ran and appeared to hide. Officers checked that area and subsequently found the subject hiding. The subject was then taken into custody. Because of Mr. Hatzenbeller's actions officers were able to locate and take into custody a subject who was wanted on a felony Probation & Parole warrant as well as two additional charges of burglary and theft. Without Mr. Hatzenbeller's involvement this subject may have eluded apprehension.



ACCREDITATION

The South Milwaukee Police Department continues its membership in the Wisconsin Law Enforcement Accreditation Group (WILEAG). This program is a continuous process enabling law enforcement agencies to evaluate, strengthen, improve and maintain their effectiveness. It works on a process of self-evaluation, keeps in check law enforcement activities, procedures and goals. It also ensures the condition of law enforcement agencies remain in compliance with established standards. The South Milwaukee Police Department has been accredited through WILEAG since May 1998. The South Milwaukee Police Department was one of the first in the State to become accredited.

The accreditation process requires the Department to have numerous policies in place and several standards met. When changes in the standards are made by the WILEAG the existing policies need to be reviewed and revised to reflect any necessary changes. This requires a continuous review of all department functions and operations. As Accreditation Manager, Captain Kallay continued to review the existing policies for required elements as well as write new policies for 2012. The Department underwent a successful re-accreditation on-site assessment in 2011. The accreditation process will continue to be a combined effort of Captain Kallay, officers and supervisory personnel who will assist in policy review and compliance.

Accreditation offers the South Milwaukee Police Department several benefits: providing “norms” against which agency performance can be monitored and measured over time; increased cooperation and coordination with other law enforcement agencies; increased effectiveness and efficiency in the delivery of law enforcement services; and demonstrating to the community that South Milwaukee Police Department possesses the professionalism it wants and deserves. The South Milwaukee Police Department is committed to continuing this leadership through the Accreditation process.

During the most recent assessment, the assessors made the following comments, “... the police department is fortunate to have a highly dedicated, proud, and professional staff. It has become apparent to the assessors that the South Milwaukee Police Department has fully embraced their role as a partner in the ongoing effort to enhance the overall quality of life in the community. As evidenced by the number of community-based programs offered, they are active in the community and seek opportunities to interact with the citizens of South Milwaukee in an effort to solve problems of mutual concern. Overall, the assessors concluded that the South Milwaukee Police Department delivers a high quality of police service to its community.”
