

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *2/8/21 – 2/21/21***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **401** calls for service.

### **BATTERY**

On February 12<sup>th</sup>, officers were dispatched to a report of a disturbance in the 1300 Block of Manitoba Avenue. Officers spoke with a 48-year-old South Milwaukee man and a 47-year-old South Milwaukee woman who stated a 29-year-old South Milwaukee man and a 28-year-old South Milwaukee woman entered their residence and struck them before damaging furniture. An investigation revealed the altercation was the result of an earlier dispute regarding snow shoveling and the locking of a common doorway. Both the 29-year-old South Milwaukee man and the 28-year-old South Milwaukee woman were issued citations for Disorderly Conduct and Battery.

On February 12<sup>th</sup>, officers were dispatched to the 700 Block of Madison Avenue for a report of an altercation between two individuals. Officers spoke with a 56-year-old Milwaukee man who claimed a 24-year-old South Milwaukee woman took money from him and struck him with a drinking glass. Both were arrested and taken to the police department where the man was issued a citation for Solicitation of Prostitution and the woman was issued citations for Prostitution and Battery.

**On February 13<sup>th</sup>, officers were dispatched to a report of a domestic disturbance at a residence in the 800 Block of Columbia Avenue. Officers spoke with a 39-year-old South Milwaukee woman who stated a 30-year-old South Milwaukee man choked her and her puppy prior to leaving the residence. The altercation was witnessed by the woman's adult daughter. The man was located later in the evening at a residence in the city of Kenosha and he was arrested and brought to the police station. He was referred to the Milwaukee County District Attorney's Office on charges of Domestic Violence Battery and Mistreatment of Animals.**

## **DRUG POSSESSION**

**On February 14<sup>th</sup>, officers were dispatched to the intersection of South Chicago Avenue and Marshall Avenue for a report of a subject passed out in a snowbank. Officers spoke with a 34-year-old South Milwaukee man who was in an incoherent state. The man was found to have confirmed warrants with the Racine County Sheriff's Department and Wisconsin Community Corrections. After being evaluated by South Milwaukee Fire Department personnel, the man was arrested and taken to the police station. The man was also found to be in possession of narcotic drugs and two knives. He was turned over to deputies from the Racine County Sheriff's Department on the warrant and was referred to the Milwaukee County District Attorney's Office on charges of Possession of Narcotics-Fentanyl and Carrying a Concealed Weapon.**

## **OPERATING WHILE INTOXICATED**

**On February 11<sup>th</sup>, officers were dispatched to a gas station in the 2300 Block of 10<sup>th</sup> Avenue for a report of vehicle driving erratically. Witnesses observed the vehicle back up several times and strike pillars near the gas pumps before parking. The driver, a 60-year-old South Milwaukee woman, showed signs of impairment. She was arrested and taken to the police station before being turned over to a sober, responsible adult. Charges of Operating While Intoxicated-2<sup>nd</sup> Offense were issued by the Milwaukee County District Attorney's Office.**
