

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *3/22/21 – 4/4/21***

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **386** calls for service.

### **WARRANT ARREST**

On April 3<sup>rd</sup>, officers were dispatched to a report of an individual passed out in the parking lot of a business in the 200 Block of North Chicago Avenue. Officers spoke with a 45-year-old West Allis man who appeared disoriented. The man was found to be in possession of illegal narcotics and was found to have a confirmed warrant with the Milwaukee County Sheriff's Office. A South Milwaukee Fire Department ambulance responded and took the man to the hospital for evaluation. After being medically cleared, he was turned over to Milwaukee County Sheriff's deputies on the warrant and referred to the Milwaukee County District Attorney's Office on a charge of Possession of Methamphetamine.

### **DISORDERLY CONDUCT**

On March 27<sup>th</sup>, officers were dispatched to the 3100 Block of South Chicago Avenue for a report of an individual urinating on a building. Officers spoke with a 54-year-old South Milwaukee man who was intoxicated and admitted to urinating on the building. He was issued a citation for Disorderly Conduct.

**On March 27<sup>th</sup>, officers were dispatched to the 1800 Block of 15<sup>th</sup> Avenue for a report of a group of people involved in an altercation after an individual struck two others with a beer bottle. Officers spoke with a 40-year-old Milwaukee man and 40-year-old Caledonia man who stated they were struck with a bottle by a 40-year-old St. Francis man following an argument. The St. Francis man was identified following an investigation and he came to the police department where he was issued a citation for Disorderly Conduct.**

### **OPERATING WHILE INTOXICATED**

**On March 25<sup>th</sup>, an officer on patrol initiated a traffic stop on a vehicle observed driving with a headlight out and deviating across the center line near North Chicago and College Avenues. The driver, a 27-year-old Milwaukee man, showed signs of impairment and drug paraphernalia was visible in the vehicle. The man also admitted to smoking marijuana recently. The man became uncooperative and was arrested and taken to the police station. He was issued citations for Possession of Drug Paraphernalia, Possession of Marijuana, Operating Without Headlamps, and No Proof of Insurance. The man was charged by the Milwaukee County District Attorney's Office with Operating While Intoxicated-2<sup>nd</sup> Offense Controlled Substance and Resisting Arrest. He was released to a sober, responsible adult.**

### **LAW ENFORCEMENT ASSIST**

**On March 23<sup>rd</sup>, officers were dispatched to the intersection of 10<sup>th</sup> and Madison Avenues for a report of a juvenile on a Milwaukee County Transit Bus that was lost. Officers spoke with a 14-year-old Franksville boy who was a reported Missing/Runaway with the Caledonia Police Department. The Caledonia Police Department was contacted and the boy's mother was notified of the situation. The boy was taken to the police department where he was picked up by his mother.**
