

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 5/17/21 – 5/30/21***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **437** calls for service.

### **DAMAGE TO PROPERTY**

On May 29<sup>th</sup>, officers were dispatched to the area near Nicholson Avenue and Hickory Street for a report of a disturbance. Officers located a 36-year-old South Milwaukee man who was in an agitated state. The man was found to be in possession of illegal narcotics and an investigation revealed he had broken a window on a garage in the 300 Block of Nicholson Avenue. The man admitted to consuming heroin and was found to be on probation for Possession of Cocaine, Burglary, Domestic Violence, and Operating While Intoxicated charges. The man was arrested and taken to the police station where he was issued citations for Disorderly Conduct and Criminal Damage to Property. He was taken to the Milwaukee County Criminal Justice Facility and was referred to the Milwaukee County District Attorney's Office on charges of Possession of a Controlled Substance-Fentanyl and Felony Bail Jumping.

### **DISORDERLY CONDUCT**

On May 17<sup>th</sup>, officers were dispatched to the 400 Block of Bay Heights Road for a report of an argument between two subjects. Officers spoke with a 28-year-old South Milwaukee woman and a 35-year-old South Milwaukee man who were involved in the argument. The man admitted to throwing furniture during the argument. He was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence Related.

## **WARRANT ARREST**

**On May 28<sup>TH</sup>, officers were dispatched to the 1100 Block of Carrington Avenue for a report of a possible battery occurring. Officers spoke with an individual boarding a Milwaukee County Transit bus near North Chicago and Badger Avenues that matched the suspect description. The individual, a 30-year-old Milwaukee man, was not the suspect from the complaint but was found to have a confirmed warrant with the Milwaukee County Sheriff's Office. The man also admitted to carrying a firearm in his pants pocket. He was arrested and turned over to Milwaukee County Sheriff's deputies on the warrant and was referred to the Milwaukee County District Attorney's Office on charges of Carrying a Concealed Weapon and Felon in Possession of a Firearm. The suspect from the original call, a 21-year-old South Milwaukee man, was located in the area a short time later and was arrested and issued a citation for Disorderly Conduct.**

## **OPERATING WHILE INTOXICATED**

**On May 29<sup>th</sup>, an officer on patrol observed a vehicle make an illegal U-turn in the 1300 Block of Milwaukee Avenue and a traffic stop was initiated in the 2100 Block of 14<sup>th</sup> Avenue. The driver, a 35-year-old Milwaukee woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Unlawful U-Turn, Operating While Intoxicated, and Operating with a Prohibited Blood Alcohol Concentration. The woman was released to a sober, responsible adult.**

**On May 22<sup>nd</sup>, officers were dispatched to the 1200 Block of Milwaukee Avenue for an accident where a vehicle had crashed into parked cars. The driver of the striking vehicle, a 28-year-old South Milwaukee man, showed signs of impairment. Marijuana was also located in the vehicle. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated, Possession of Marijuana, Inattentive Driving, Failure to Wear a Seatbelt, and Operating a Motor Vehicle Without Insurance. He was released to a sober, responsible adult.**
