

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *6/14/21 – 6/27/21***

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **493** calls for service.

### **RESTRAINING ORDER VIOLATION**

On June 17<sup>TH</sup>, officers were dispatched to the 2400 Block of Harrison Place for a report of an unwanted person. A resident reported discovering a 60-year-old South Milwaukee man in the bushes near the garage of the residence. A confirmed Domestic Violence Injunction was in place against the man prohibiting contact at the residence. The man was located nearby and admitted to being in the area in an attempt to contact the resident. He was arrested and taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Violating a Domestic Abuse Injunction.

### **THEFT**

On June 24<sup>TH</sup>, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of an individual leaving a business without paying for shaving razors. The individual left identifying information in another section of the store and officers made contact with a 64-year-old Oak Creek man at his residence. The man matched the description viewed on surveillance video and was in possession of the razors without a receipt. He was issued a citation for Retail Theft.

On June 22<sup>nd</sup>, officers were dispatched to the 200 Block of North Chicago Avenue for a report of a stolen bike. Officers spoke with a 54-year-old South Milwaukee man who reported an unidentified female rode off on his bicycle while it was parked near a business in the area. The bicycle was located abandoned in the city of Cudahy and was returned to the man. An investigation is ongoing to attempt to identify the unidentified female suspect.

## **OPERATING WHILE INTOXICATED**

On June 27<sup>TH</sup>, officers were dispatched to the 1200 Block of Milwaukee Avenue for a report of a vehicle driving erratically and striking the curb. The vehicle was located parked with significant damage and witnesses provided officers with a description of the driver and direction of travel. Officers located a 30-year-old South Milwaukee woman who matched the description given. The woman admitted to driving the vehicle and showed signs of impairment. She was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-2<sup>nd</sup> Offense. She was released to a sober, responsible adult.

On June 25<sup>th</sup>, an officer on patrol noticed smoke coming from a vehicle driving on South Chicago Avenue and a traffic stop was initiated near Drexel Boulevard. The officer noticed the air bag was deployed and the driver, a 49-year-old South Milwaukee woman, showed signs of impairment. A short time later a damaged vehicle was located near 11<sup>th</sup> and Blake Avenues and a 23-year-old Twin Falls, Idaho man stated the vehicle from the traffic stop crashed into him while he was at the traffic signal at South Chicago and Columbia Avenues. The South Milwaukee woman was arrested and issued citations for Operating While Intoxicated, Operating with a Prohibited Blood Alcohol Concentration, and Hit and Run.

## **DISORDERLY CONDUCT**

On June 25<sup>TH</sup>, officers were dispatched to the 3500 Block of 9<sup>th</sup> Avenue for a report of a disorderly subject. A 27-year-old South Milwaukee woman stated a 54-year-old South Milwaukee man was yelling and shouting at her after previously being warned on a loud music complaint. An officer viewed a video of the man yelling at the woman. The man admitted to not getting along with the woman and yelling at her. He was issued a citation for Disorderly Conduct.

On June 15<sup>th</sup>, officers were dispatched to the 1800 Block of Rawson Avenue for a noise complaint with an individual talking loudly. Officers spoke with a 62-year-old South Milwaukee man who stated he was talking on his phone. The man was warned on the noise complaint. As officers were leaving, the man was heard shouting again and he was issued a citation for Unnecessary Noise.
