

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *8/23/21 – 9/5/21*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **491** calls for service.

DISORDERLY CONDUCT

On August 29TH, officers were dispatched to the 1300 Block of Milwaukee Avenue for a report of a group of individuals involved in an altercation. Witnesses on scene advised officers a subject later identified as a 35-year-old Chicago, Illinois man, exited a parked vehicle and began threatening several people. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

On August 31st, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual acting disorderly. Employees stated a 35-year-old Milwaukee man became upset when told to refrain from using loud profanities and slurs while talking on his phone. The man damaged furniture and struck an employee before causing further damage by kicking the entrance door. The man left the scene prior to the arrival of officers and was identified via records from the business. He was issued citations for Disorderly Conduct and Criminal Damage to Property.

CRIMINAL DAMAGE TO PROPERTY

On August 31^s, officers were dispatched to the 2800 Block of South Chicago Avenue for a report of an individual breaking a window. A witness advised officers a 37-year-old South Milwaukee man broke the window and left the area. The man was located at his residence where he was arrested and issued a citation for Criminal Damage to Property.

STOLEN VEHICLE RECOVERY

On August 28th, an officer on patrol noticed a vehicle parked in the 400 Block of Marion Avenue with no front plate and deflated rear tires. The rear license plate did not match the vehicle and when the Vehicle Identification Number registration was checked, the vehicle was found to have been reported stolen with the Milwaukee Police Department. The vehicle was towed to a lot and the registered owner was notified of its location. The investigation was turned over to the Milwaukee Police Department.

RETAIL THEFT

On August 31st, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual leaving the store without paying for items. Officers located the individual running in the 6100 Block of S Packard Avenue in the city of Cudahy. He was taken into custody and identified as a 33-year-old South Milwaukee man. The items taken were recovered and the man was found to be in possession of drug paraphernalia and had a confirmed warrant with the Waukesha County Sheriff. He was arrested and issued citations for Retail Theft, Resisting an Officer, and Possession of Drug Paraphernalia before being taken to the Waukesha County Jail on the warrant.

On September 2nd, security personnel from a business in the 200 Block of North Chicago Avenue reported an individual threw a pen at an employee and took an item from the store without paying for it. Officers observed surveillance video that showed a woman throw a pen at an employee before taking a purse and leaving without paying for it. The woman was identified through records from the business as a 28-year-old South Milwaukee woman. She was issued citations for Disorderly Conduct and Theft.

WARRANT ARREST

On August 23rd, an officer on patrol observed a vehicle fail to come to a complete stop at the stop sign at 6th and Milwaukee Avenues and a traffic stop was initiated. The driver, a 20-year-old South Milwaukee man, was found to have a confirmed felony warrant with the Milwaukee County Sheriff's Office. He was arrested and taken to the police station where he was turned over to deputies from the Milwaukee County Sheriff's Office on the warrant.
