

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *9/20/21 – 10/3/21*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **510** calls for service.

WARRANT ARREST

On September 26th, officers were dispatched to the 2400 Block of Nicholson Avenue for a report of two individuals arguing. Officers spoke with a 39-year-old South Milwaukee woman who was involved in a verbal argument with a 49-year-old Milwaukee man. The man was found to have a confirmed felony warrant with the Milwaukee County Sheriff's Office. He was arrested and turned over to Milwaukee County Sheriff's deputies on the warrant.

LAW ENFORCEMENT ASSISTANCE

On September 25th, officers were dispatched to Grant Park for a report of an individual inside a vehicle threatening to harm themselves. South Milwaukee officers and Milwaukee County Sheriff's deputies responded and located the vehicle occupied by a woman who was undergoing a crisis episode. The woman refused to turn the vehicle off and unlock the door and stop sticks were used to keep the vehicle from fleeing. Officers continued to speak with the woman and eventually were able to unlock the vehicle and take her into protective custody. She was turned over to Milwaukee County Sheriff's deputies.

DISORDERLY CONDUCT

On October 2nd, officers were dispatched to the 1300 Block of Noel Court for a report of juveniles refusing to leave after a resident declined to purchase candy they were selling. Officers spoke with the juveniles who were uncooperative and refused to identify themselves. They were taken to the police station and identified as a 13-year-old Milwaukee boy and an 11-year-old Milwaukee boy. They were issued citations for Disorderly Conduct and turned over to a family member.

MOTOR VEHICLE ACCIDENT

On October 2nd, officers were dispatched to the 600 Block of the Oak Creek Parkway for a report of a motor vehicle accident. Officers located an overturned vehicle in the Grant Park Lagoon and two individuals nearby who were wet and covered in mud. The individuals were identified as a 21-year-old South Milwaukee man who was the driver of the vehicle and a 47-year-old Milwaukee man who was the passenger. Neither man was injured and witnesses stated the vehicle crashed after driving too fast for the curves. The South Milwaukee man was issued citations for Reckless Driving, Unreasonable and Imprudent Speed, and Operating Without a License.

RETAIL THEFT

On September 24th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual leaving the store without paying for automotive items. Officers located the individual nearby in the city of Cudahy with the missing items and he was identified as an 18-year-old Milwaukee man. He was arrested and taken to the police station where he was issued a citation for Retail Theft.

On September 28th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual placing items in a backpack and leaving the store without paying for them. Upon arrival, witnesses directed officers to a man nearby that matched the description of the individual who took the items. He was identified as a 53-year-old Milwaukee man and he admitted to taking the items from the store which were found in his possession. He was arrested and taken to the police station where he was issued a citation for Retail Theft.

OPERATING WHILE INTOXICATED

On September 28th, officers were dispatched to an accident near 15th and Rawson Avenues where a parked vehicle was struck. A witness also reported the striking vehicle driving erratic prior to the accident. The driver of the striking vehicle who was identified as a 30-year-old Burlington woman, showed signs of impairment. She was arrested and issued a citation for Operating While Intoxicated-First Offense. The woman reported injuries from the accident and South Milwaukee Fire Department personnel arrived on the scene and took her to the hospital. She was turned over to a sober, responsible adult at the hospital.
