

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *11/01/21 – 11/14/21*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **498** calls for service.

WEAPONS VIOLATION

On November 2nd, a 911 caller reported an intruder in an apartment in the 1800 Block of Rawson Avenue and hung up. As officers were en route, numerous other 911 calls were received reporting gun shots in the area. Officers located a 23-year-old Milwaukee man in the area suffering from a gunshot wound to the leg. South Milwaukee Fire Department personnel responded and transported the male to a hospital. A 22-year-old South Milwaukee woman was taken into custody at the scene. The man was found to have confirmed warrants with the Milwaukee County Sheriff's Office for Endangering Safety/Reckless Use of a Firearm and Felony Bail Jumping-DV Related. The man was charged by the Milwaukee County District Attorney's Office with three counts of Felony Bail Jumping with Domestic Abuse and Habitual Criminality Repeaters and the woman was referred to the Milwaukee County District Attorney's Office on charges of Reckless Injury and Endangering Safety-DV Related.

HIT AND RUN ACCIDENT

On November 1st, officers were dispatched to a business in the 200 Block of North Chicago Avenue after a 70-year-old St. Francis woman reported her vehicle was struck and damaged in the parking lot. Officers viewed surveillance video and were able to obtain registration information on the striking vehicle. Officers made contact with a 78-year-old Cudahy man who was the owner of the striking vehicle. He admitted to hitting the vehicle in the lot and was issued a citation for Hit and Run.

WARRANT ARREST

On November 5th, officers were provided information from the Milwaukee Police Department that an individual with a felony warrant for First Degree Sexual Assault of a Child was expected to be in South Milwaukee. Officers located the individual, a 58-year-old Milwaukee man, driving near South Chicago Avenue and Drexel Boulevard. A traffic stop was initiated near 15th Avenue and Drexel Boulevard and the man was arrested. He was taken to the police station where he was turned over to officers from the Milwaukee Police Department on the warrant.

On November 12th, officers received information an individual with confirmed warrants was at a residence in the 100 Block of 14th Avenue. Upon arrival, the individual, a 21-year-old South Milwaukee woman, was observed exiting the rear of the residence. The woman was found to have a confirmed felony warrant for Identity Theft from the Dodge County Sheriff's Department and a confirmed misdemeanor warrant for Theft from the Washington County Sheriff's Department. She was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrants.

OPERATING WHILE INTOXICATED

On November 13th, a citizen reported a vehicle driving erratically and nearly striking other vehicles. Officers located the vehicle and initiated a traffic stop near North Chicago and Davis Avenues. The driver, a 42-year-old South Milwaukee man showed signs of impairment. He was arrested and issued citations for Operating While Intoxicated-Sixth Offense and Operating a Motor Vehicle Without Insurance before being taken to the Milwaukee County Criminal Justice Facility.

On November 12th, officers were dispatched to the 1800 Block of College Avenue for a report of a vehicle accident. Officers located a vehicle parked with extensive damage and a 36-year-old Milwaukee woman nearby who stated she was the driver. A fluid trail, tire marks, and vehicle debris indicated the vehicle left the roadway in the city of Oak Creek and struck a road sign before stopping in the 1800 Block of College Avenue. The woman showed signs of impairment and she was arrested. She was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-Third Offense and Operating With a Prohibited Blood-Alcohol Concentration-Third Offense.
