

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *11/15/21 – 11/28/21*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **435** calls for service.

WARRANT ARREST

On November 27th, officers located an occupied vehicle parked at the Grant Park Main Beach after closing hours. An odor of marijuana was present and officers spoke with a 28-year-old Milwaukee man, a 22-year-old Milwaukee woman, and a 25-year-old Port Washington woman who were the occupants of the vehicle. The man was found to have a confirmed warrant with the Milwaukee County Sheriff's Office for Disorderly Conduct, Battery, and Criminal Damage to Property. Marijuana, drug paraphernalia, and other narcotics were located in the vehicle. All three were arrested and brought to the police station. All three were issued citations for Violation of Park Closing Hours and the 22-year-old woman received citations for Possession of Marijuana and Possession of Drug Paraphernalia while the man received a citation for Possession of Synthetic Cannabinoid. All three individuals were referred to the Milwaukee County District Attorney's Office on charges of Possession of Fentanyl and the man was turned over to Milwaukee County Sheriff's deputies on the warrant.

On November 23rd, officers located an occupied vehicle parked in Grant Park after closing hours. An odor of marijuana was present and officers spoke with the occupants, a 32-year-old Milwaukee man and a 31-year-old Milwaukee woman. The man was found to have a confirmed warrant with the Milwaukee County Sheriff's Office for Battery and Disorderly Conduct. Both individuals were arrested and issued citations for Violation of Park Hours, Possession of Marijuana, and Possession of Drug Paraphernalia. The man was turned over to Milwaukee County Sheriff's deputies on the warrant.

STOLEN VEHICLE RECOVERY

On November 20th, officers were dispatched to the 1800 Block of Drexel Boulevard for a report of an argument between three individuals by a vehicle. Officers located a 57-year-old Milwaukee man by a parked truck while a 23-year-old Milwaukee woman and a 28-year-old West Allis woman were located nearby. An investigation revealed the West Allis woman had the keys to the vehicle and was driving before beginning to argue with the other two individuals. The truck was listed as stolen from the city of Milwaukee and the West Allis woman was found to be in possession of property belonging to the vehicle owner as well as drug paraphernalia and narcotics. The Milwaukee woman was also found to be in possession of drug paraphernalia. The truck and property were released to its rightful owner. The Milwaukee woman was arrested and issued a citation for Possession of Drug Paraphernalia and the West Allis woman was arrested and issued citations for Possession of Drug Paraphernalia and Receiving Stolen Property. The West Allis woman was taken to the Milwaukee County Criminal Justice Facility and was later charged by the Milwaukee County District Attorney's Office with Operating a Motor Vehicle Without Owner's Consent and Possession of Methamphetamine.

OPERATING WHILE INTOXICATED

On November 26th, an officer on patrol in the 2400 Block of 15th Avenue observed a vehicle travelling northbound in the southbound lane of travel and a traffic stop was initiated in the 1400 Block of Michigan Avenue. The driver, a 39-year-old Milwaukee man showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense, Operating with Prohibited Blood-Alcohol Concentration, Deviating from the Lane of Traffic, Operating After Revocation, Operating Without Insurance, and Open Intoxicants in a Vehicle. He was released to a sober, responsible adult.

DISORDERLY CONDUCT

On November 19th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual kicking the walls and acting disorderly. Officers spoke with an uncooperative man who was shouting profanities and refusing to identify himself. He was later identified as a 32-year-old Cudahy man and was previously banned from the business. He was arrested and issued citations for Trespassing, Disorderly Conduct, and Possession of Drug Paraphernalia after a drug pipe was located in his pocket.
