

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *11/29/21 – 12/12/21***

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **460** calls for service.

### **DISORDERLY CONDUCT**

On December 10<sup>th</sup>, a man and a woman entered a business in the 1000 Block of Marquette Avenue and attempted to obtain money using an account in another individual's name. When they were denied, both shouted profanities and the man set off the fire extinguisher before leaving the scene. The individuals were identified as a 31-year-old South Milwaukee man and a 27-year-old South Milwaukee woman and the man was also identified as a suspect in thefts from vehicles in the 1300 Block of Marquette Avenue the same day. Both were located the following day while responding to a Disorderly Conduct call in the 800 Block of Lakeview Avenue. The woman was issued a citation for Disorderly Conduct while the man was issued citations for Disorderly Conduct, Criminal Damage to Property, and Theft.

On November 29<sup>th</sup>, officers were dispatched to the 1100 Block of Marshall Avenue for a report of an individual burning items following an argument. Officers located a 28-year-old South Milwaukee woman near a small fire that was not contained in a fire pit. A 35-year-old South Milwaukee man stated the woman was burning his clothes after he left following an argument. The woman admitted to burning the man's clothes and the South Milwaukee Fire Department responded to extinguish the fire. The woman was arrested and taken to the Milwaukee County Criminal Justice Facility before being charged by the Milwaukee County District Attorney's Office with Criminal Damage to Property and Disorderly Conduct-Domestic Violence Related.

## **WARRANT ARREST**

On December 11<sup>th</sup>, officers were dispatched to a report of a reckless driver in a parking lot in the 2900 Block of South Chicago Avenue. Officers located the vehicle parked unoccupied and running at a business in the 3100 Block of South Chicago Avenue. Officers spoke with a man observed leaving the area quickly on foot. The man originally provided false identification information but was eventually identified as a 34-year-old Milwaukee man and he admitted to driving the vehicle. Drug paraphernalia was located in the vehicle and the man was found to have confirmed warrants with the Milwaukee County Sheriff's Office and the Delafield Police Department. The man was arrested and issued citations for Obstructing and Possession of Drug Paraphernalia before being turned over to officers from the Delafield Police Department on the warrants.

## **OPERATING WHILE INTOXICATED**

On December 3<sup>rd</sup>, an officer on patrol observed a vehicle fail to stop at a stop sign after making a turn near South Chicago and Marquette Avenues and a traffic stop was initiated in the 1000 Block of Marquette Avenue. The driver, a 31-year-old Cudahy man, showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense, and Operating After Suspension. He was released to a sober, responsible adult.

## **TRAFFIC VIOLATION**

On December 3<sup>rd</sup>, an officer on patrol observed a vehicle enter the intersection at 17<sup>th</sup> and Rawson Avenues against the red traffic light and a traffic stop was initiated in the 1500 Block of Rawson Avenue. The driver, a 33-year-old Milwaukee woman did not have a valid driver's license and an odor of marijuana was present. The woman did not show signs of impairment. Marijuana was located in the vehicle. The woman was issued citations for Operating After Suspension, Violation of a Traffic Signal, and Possession of Marijuana.
