

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *12/13/21 – 12/26/21*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **426** calls for service.

WEAPONS VIOLATION

On December 19TH, officers were dispatched to the 400 Block of Marquette Avenue for a report of an individual being cut with a knife. Officers spoke with a 52-year-old South Milwaukee man with a minor cut wound. The man stated he shouted at a vehicle that nearly struck him while crossing the street and after the vehicle stopped, the driver exited and cut him before leaving the scene. The man was taken to the hospital by South Milwaukee Fire Department personnel. Later, a 23-year-old South Milwaukee man called the police department and admitted his involvement in the incident. He was arrested at his residence and taken to the Milwaukee County Criminal Justice Facility. He was charged by the Milwaukee County District Attorney's Office with Battery and Disorderly Conduct-Use of a Dangerous Weapon.

DISORDERLY CONDUCT

On December 23rd, officers were dispatched to a business in the 1400 Block of Missouri Avenue for a report of an individual who was asked to leave earlier, returning and kicking the door. Witnesses identified the individual as a 28-year-old South Milwaukee man who was located nearby. The man was intoxicated and admitted to being at the business. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

On December 19th, officers were dispatched to a residence in the 1400 Block of Missouri Avenue for a report of an intoxicated individual acting disorderly. Officers spoke with a 56-year-old South Milwaukee woman who stated a 27-year-old Milwaukee man refused to leave the residence. The man was intoxicated and became uncooperative. He was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct-Domestic Violence related and Resisting an Officer.

On December 20th, officers were dispatched to a business in the 1100 Block of Milwaukee Avenue for a report of a disorderly individual. Officers located an intoxicated 37-year-old Benton, Arkansas man outside the business. South Milwaukee Fire Department personnel arrived and transported the man to a hospital. The man became uncooperative at the hospital and began to shout profanities. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct. The man was released after sobering up.

DRUG INVESTIGATION

On December 22nd, an officer on patrol observed an individual in a parked vehicle in an alley engage in a suspicious transaction with another individual. The officer observed the vehicle leave and commit a stop light violation at the intersection of 13th and Milwaukee Avenues. A traffic stop was initiated in the 1400 Block of Milwaukee Avenue. The driver, a 30-year-old Milwaukee man, admitted to having a gun in the vehicle without a Concealed Carry license. A gun and a substantial amount of marijuana was located in the vehicle. The man admitted to selling the marijuana. He was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Possession With Intent to Distribute While Armed.

RETAIL THEFT

On December 14th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual eating food from the business and not paying for it. Officers located a 25-year-old Milwaukee man sitting in the café area eating food from the store. The man stated he did not intend to pay for the items he was eating and he was arrested. He was taken to the police station and issued a citation for Retail Theft.
