

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *12/27/21 – 1/9/21*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **367** calls for service.

OPERATING WHILE INTOXICATED

On December 31st, an officer on patrol observed a vehicle cross the center line in the 1800 Block of Rawson Avenue and then swerve to travel in the parking lane. The vehicle signaled a turn at the intersection of 17th and Rawson Avenues but continued straight and a traffic stop was initiated in the 1600 Block of Rawson Avenue. An open liquor bottle was observed in the vehicle and the driver, a 40-year-old Sheboygan man, showed signs of impairment. The man was arrested and taken to the police station where he became uncooperative. He was referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-2nd Offense and he was issued citations for Operating Left of Center, Possession of Open Intoxicants in a Motor Vehicle, Operating After Revocation, Failure to Install Interlock Ignition Device, and Disorderly Conduct.

On December 28th, officers were dispatched to the area of Lake Drive and Badger Avenue for a report of a vehicle that left the roadway and struck a tree. Officers spoke with the driver, a 52-year-old South Milwaukee man who showed signs of impairment. South Milwaukee Fire Department personnel transported the man to a hospital for treatment of minor injuries. He was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-3rd Offense. He was released to a sober responsible adult.

On December 27th, an officer on patrol observed a vehicle traveling over the posted speed limit and a traffic stop was initiated in the 1800 Block of College Avenue. The driver, a 29-year-old Oak Creek man showed signs of impairment and he was arrested. He was taken to the police station where he was issued citations for Operating While Intoxicated-First Offense and Speed Above Posted Limits. He was released to a sober responsible adult.

On January 4th, an officer on patrol observed a vehicle operating without headlights make a wide turn and swerve within the lane of travel in the 2300 Block of 10th Avenue and a traffic stop was initiated. The driver, a 34-year-old Cudahy man, showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating Without Headlamps and Operating While Intoxicated-First Offense. He was released to a sober responsible adult.

DISORDERLY CONDUCT

On December 29TH, officers were dispatched to the 400 Block of Southtowne Drive for a report of individuals involved in an argument. Officers spoke with a 21-year-old South Milwaukee man and a 31-year-old South Milwaukee woman who were involved in the argument as well as a witness on the scene. After an investigation the man was arrested and taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on Domestic Violence charges.

On December 31st, officers were dispatched to the 900 Block of Manitoba Avenue for a report of individuals involved in an argument. Officer spoke with a 32-year-old South Milwaukee woman and a 45-year-old South Milwaukee man who were involved in the argument. After an investigation the woman was arrested and taken to the Milwaukee County District Attorney's Office on Domestic Violence charges.
