

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 4/4/22 – 4/17/22



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **389** calls for service.

BATTERY

On April 13th, officers were dispatched to the 900 Block of Milwaukee Avenue for a report of individuals in a physical altercation. Officers spoke with a 34-year-old Milwaukee man and a 35-year-old South Milwaukee man who appeared to have minor injuries and stated they were battered by individuals they had gotten into a verbal argument with earlier in the 500 Block of Madison Avenue. After speaking with witnesses and viewing surveillance video the suspected individuals were identified as two 41-year-old South Milwaukee men and a 40-year-old Racine man. The South Milwaukee men were located, arrested and later charged with Battery by the Milwaukee County District Attorney's Office. The Racine man was issued a citation for Disorderly Conduct.

On April 13th, officers were dispatched to a business in the 2300 Block of 10th Avenue for a report of an individual striking an employee. Officers spoke with the employee who stated a man punched him after he was advised he did not have enough money for the items he wished to purchase. The man left the business prior to the arrival of officers. He was identified as a 30-year-old South Milwaukee man who was located a short time later. The man admitted to punching the employee and he was arrested. He was taken to the police station where he was issued a citation for Battery.

DISORDERLY CONDUCT

On April 9th, an officer on patrol observed an individual urinating in a yard near 4th and Montana Avenues. He was identified as a 51-year-old South Milwaukee man and was issued a citation for Disorderly Conduct.

On April 14th, officers were dispatched to the 1400 Block of Rawson Avenue for a report of two individuals involved in a disturbance. Officers spoke with a 26-year-old Milwaukee man and a 40-year-old Greenfield man who were involved in the altercation. After speaking with witnesses, both men were arrested and taken to the police station where they were issued citations for Disorderly Conduct before being released.

On April 15th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an intoxicated individual creating a disturbance. Officers spoke with a 39-year-old Milwaukee man who appeared intoxicated and admitted to having consumed alcohol. He became uncooperative and was arrested after he refused to leave the area. He was taken to the police station and issued citations for Disorderly Conduct and Resisting/Obstructing.

OPERATING WHILE INTOXICATED

On April 5th, officers were dispatched to a report of an individual passed out in a running vehicle in a parking lot in the 2900 Block of South Chicago Avenue. Officers spoke with the driver, a 39-year-old Oak Creek woman who woke up and showed signs of impairment. The vehicle had damage and the woman admitted to being in an accident earlier in the city of Milwaukee. Several prescription narcotics were located in the vehicle and the woman was arrested. She was also found to have an open case from Racine County with the condition of bail being she not to be driving or consuming controlled substances. The woman was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-Fifth Offense, Operating While Revoked, Failure to Install an Ignition Interlock Device, Possession of Controlled Substances, and Bail Jumping.

WARRANT ARREST

On April 4th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual in the bathroom who had thrown clothes all over the floor. Officers located a 27-year-old Milwaukee man attempting to brush his teeth in the bathroom. He was found to have a confirmed warrant with the Waukesha County Sheriff's Office. He was arrested and taken to the Waukesha County Jail on the warrant.
