

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 4/18/22 – 5/1/22**

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **435** calls for service.

### **DISORDERLY CONDUCT**

On April 27<sup>TH</sup>, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of individuals causing a disturbance. The individuals, a 39-year-old Oak Creek woman and a 40-year-old Oak Creek man, left prior to the arrival of officers but were later involved in a separate incident in the city of Oak Creek. They were advised by Oak Creek police officers they were no longer allowed in the business. On April 28<sup>th</sup>, officers were dispatched back to the business as both individuals had returned and they were issued citations for Trespassing.

### **WARRANT ARREST**

On April 27<sup>th</sup>, an officer on traffic patrol observed a vehicle travelling 51mph in a 25mph speed zone and a traffic stop was initiated in the 1800 Block of Drexel Boulevard. The driver, a 46-year-old Oak Creek man, was found to have a confirmed felony warrant with the Wisconsin Department of Corrections for a parole violation. Drug paraphernalia was also located in the vehicle. The man was arrested and issued citations for Exceeding Speed Zones (25-29mph), Operating after Revocation, and Possession of Drug Paraphernalia. He was taken to the Milwaukee County Criminal Justice Facility on the warrant.

## **THEFT**

**On April 26<sup>th</sup>, officers were dispatched to the area of Nicholson Avenue and College Avenue after a 23-year-old South Milwaukee woman reported three individuals stole her phone and other items from her vehicle. The woman reported she had run out of gas and the three individuals were acquaintances who offered to assist her before taking the items and leaving the area. The individuals, later identified as a 32-year-old Milwaukee man, a 27-year-old Waukesha woman, and a 23-year-old West Allis man, were located and stopped in the city of St. Francis by officers from the St. Francis Police Department. The woman's property was located in their vehicle along with numerous other narcotics. All three were arrested and taken to the police department where they were issued citations for Theft. The 32-year-old man was referred to the Milwaukee County District Attorney's Office on charges of Possession of Narcotics with Intent to Deliver.**

## **OPERATING WHILE INTOXICATED**

**On April 25<sup>th</sup>, officers were dispatched to the 600 Block of Madison Avenue for a report of a vehicle accident. Officers located a damaged vehicle that appeared to have struck a nearby tree. The driver, a 31-year old South Milwaukee woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-First Offense, and Inattentive Driving. She was released to a sober, responsible adult.**

**On April 21<sup>st</sup>, officers were dispatched to the area of South Chicago and Forest Hill Avenues for a report of a vehicle striking an electrical pole. Officers located a sheared off pole and a damaged vehicle nearby rolled on its side. The driver, a 21-year-old Oak Creek woman, showed signs of impairment. Both the driver and passenger, a 21-year-old Racine woman, were taken to the hospital by South Milwaukee Fire Department personnel for treatment of possible injuries. The Oak Creek woman was later issued a citation for Operating While Intoxicated-First Offense.**
