

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 5/30/22 – 6/15/22



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **460** calls for service.

OPERATING WHILE INTOXICATED

On June 14th, officers were dispatched to 9th and Columbia Avenues for a report of a vehicle striking a mailbox and a stop sign before leaving the area. Witnesses showed officers a short video of the incident in which the vehicle's license plate could be read. The vehicle was located at the registered owner's residence in the 700 Block of Edgewood Avenue with fresh damage. The owner, a 61-year-old South Milwaukee woman, admitted to driving the vehicle and striking the mailbox and stop sign. She showed signs of impairment and was arrested before being taken to the Milwaukee County Criminal Justice Facility. She was referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-Fourth Offense.

WARRANT ARREST

On June 4th, officers were dispatched to the area of 17th Avenue and Cherry Street for a report of a vehicle parked and occupied by an individual who appeared to be sleeping. Officers were able to wake up the individual, a 38-year-old Cudahy woman. She was found to have a confirmed felony Probation and Parole warrant with the Wisconsin Department of Corrections and a confirmed warrant for Retail Theft with the Oak Creek Police Department. She was arrested and taken to the police station where she signed a personal recognizance bond on the Oak Creek warrant and was taken to the Milwaukee County Criminal Justice Facility on the felony Probation and Parole warrant.

DRUG POSSESSION

On June 15th, officers were dispatched to the 1800 Block of Drexel Boulevard to attempt to locate an individual wanted by the Milwaukee Police Department for questioning in a felony case. Officers located the individual, a 43-year-old Milwaukee man, who was also found to be in possession of illegal narcotics. He was arrested and turned over to officers from the Milwaukee Police Department. He was also referred to the Milwaukee County District Attorney's Office on a charge of Possession of Cocaine.

DISORDERLY CONDUCT

On June 10th, officers were dispatched to the 1100 Block of Milwaukee Avenue for a report of individuals involved in an argument. Officers spoke with a 28-year-old South Milwaukee man who stated he was involved in a verbal argument with a 32-year-old South Milwaukee man. The 32-year-old man was intoxicated and originally provided false identification information while continuing to be uncooperative. He was arrested and taken to the police station where he was issued citations for Disorderly Conduct and Obstructing.

On June 12th, officers were dispatched to the 1600 Block of Monroe Avenue for a report of a disturbance between two individuals. Officers spoke with a 51-year-old South Milwaukee man who stated he was conversing with a 31-year-old Milwaukee woman when a 37-year-old Cudahy man pushed him off a stool. The South Milwaukee man was not injured in the altercation and denied medical attention while the Cudahy man was issued a citation for Disorderly Conduct.

RETAIL THEFT

On June 1st, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual attempting to leave without paying for items. Officers spoke with a 38-year-old Milwaukee man who was observed by store security concealing headphones and batteries in a backpack he was carrying. The unpaid for merchandise was located inside the individual's backpack and he was arrested. He was taken to the police station and issued a citation for Retail Theft.
