

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 6/27/22 – 7/10/22**

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **532** calls for service.

### **ROBBERY**

On July 4<sup>th</sup>, a resident in the 2400 Block of Nicholson Avenue reported being robbed of a phone, credit cards and a watch by a male subject who was in possession of a firearm. The victim's credit cards were fraudulently used and an investigation linked the suspect with two car jackings in the city of Milwaukee. On July 7<sup>th</sup>, officers from the Franklin Police Department were alerted to a stolen vehicle at a business in the 6700 Block of S. 27<sup>th</sup> Street and an individual was arrested after a brief pursuit. The individual, a 19-year-old Milwaukee man, admitted to the Milwaukee car jackings and the South Milwaukee robbery. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on multiple charges including Armed Robbery and Fraudulent Use of a Credit Card from the South Milwaukee case.

### **DISORDERLY CONDUCT**

On July 1<sup>st</sup>, officers were dispatched to a business in the 100 Block of North Chicago Avenue for a report of an individual who yelled at employees and damaged a counter with a knife. Officers located the individual, a 35-year-old Mukwonago man, in the 200 Block of Southtowne Drive. The man became uncooperative as he was arrested and a knife was located in his pocket. He was taken to the Milwaukee County Criminal Justice Facility and later charged by the Milwaukee County District Attorney's Office with Disorderly Conduct and Criminal Damage to Property-Use of a Dangerous Weapon, and Obstructing.

**On July 10<sup>th</sup>, officers were dispatched to the 1100 Block of Milwaukee Avenue for a report of a male exposing himself to a female in the alley. The male left the area prior to the arrival of officers and surveillance video captured the incident. The man was located a short time later near North Chicago and Hawthorne Avenues. He was identified as a 31-year-old Cudahy man and he stated he was urinating in the alley. He was arrested and issued citations for Disorderly Conduct and Lewd and Lascivious Behavior.**

### **DRUG INVESTIGATION**

**On July 3<sup>rd</sup>, officers were dispatched to the 1300 Block of Rawson Avenue for a report of a female who appeared to be passed out on a front step. Officers located a 32-year-old West Allis woman who was awake but appeared lethargic. Needles and other drug paraphernalia were located in her possession as well as a small amount of heroin. The woman also had confirmed warrants with the Jefferson County Sheriff's Office and the Waukesha County Sheriff's Office. South Milwaukee Fire Department personnel responded to provide medical assistance and she was taken to the hospital for evaluation. She was issued citations for Possession of Drug Paraphernalia-Heroin and Cocaine and was referred to the Milwaukee County District Attorney's Office on a charge of Possession of Heroin.**

### **OPERATING WHILE INTOXICATED**

**On July 5<sup>th</sup>, officers were dispatched to a report of a reckless driver and possible vehicle crash in the 2800 Block of 9<sup>th</sup> Avenue where a man was trying to get into other people's vehicles. Officers located an unoccupied vehicle parked sideways in the road and running. The driver, a 40-year-old Oak Creek man, was located nearby and appeared to be under the influence of narcotics. The man became uncooperative and was arrested. South Milwaukee Fire Department personnel responded and transported the man to a hospital for evaluation. He was referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-Fifth Offense, Operating While Revoked, and Resisting/Obstructing an Officer.**
