

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 7/25/22 – 8/7/22



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **473** calls for service.

DISORDERLY CONDUCT

On August 7th, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of an individual displaying a firearm after being involved in an argument. Witnesses stated the individual with the firearm originally left the area but later returned. Officers spoke with a 48-year-old South Milwaukee man who matched the description and admitted to being involved in an argument. No firearm was located but surveillance video showed the man with a firearm and he was arrested. He was taken to the Milwaukee County Criminal Justice Facility and later charged by the Milwaukee County District Attorney's Office with Disorderly Conduct While Armed.

On July 29th, officers on foot patrol in the 1700 Block of 16th Avenue were approached by a woman and child who stated another woman was bothering them. Officers spoke with a 27-year-old South Milwaukee woman who was intoxicated and yelling loudly. When she attempted to hit the woman who approached the officers, she was arrested. She became uncooperative and was taken to the police station. The woman was on probation from an operating while intoxicated case and the Wisconsin Department of Corrections requested a hold be placed on her. The woman requested medical attention and was taken to a hospital by South Milwaukee Fire Department personnel for observation. While at the hospital, the woman continued to be uncooperative and kicked officers. Once cleared, the woman was taken to the Milwaukee County Criminal Justice Facility on the hold and referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct, Resisting and Obstructing, and Battery to a Law Enforcement Officer. She was also issued a citation for Possession of Marijuana after marijuana was located in her purse.

BATTERY

On July 26th, a 28-year-old South Milwaukee woman reported being battered by a 30-year-old South Milwaukee woman in the 400 Block of North Chicago Avenue. The 28-year-old woman reported being pulled down stairs by the 30-year-old woman causing her to strike her head and resulting in a minor injury. Officer spoke with a 35-year-old South Milwaukee man who witnessed the incident and the 30-year-old woman who admitted to being involved in the altercation. She was arrested and issued a citation for Battery.

RETAIL THEFT

On August 6th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual opening packages of razors and concealing them in his pockets in an attempt to leave without paying for them. Officers spoke with a 25-year-old Cudahy man who admitted attempting to steal the razors. He was arrested and issued a citation for Retail Theft.

WARRANT ARREST

On July 26th, officers were dispatched to a business in the 200 Block of North Chicago for a report of an individual who entered the business with a backpack and attempted to steal items but left the store when confronted by employees. Officers located a 25-year-old Cudahy man at the corner of North Chicago and College Avenues that matched the description given. The man admitted to being in the business and was found to have two confirmed warrants with Community Corrections and the Milwaukee County Sheriff's Office. He was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrant and was issued a citation for Possession of Drug Paraphernalia after a crack pipe was located in his pocket.
