

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 10/17/22 – 10/30/22

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **404** calls for service.

DISORDERLY CONDUCT

On October 24th, officers were dispatched to a report of a vehicle accident near 13th and Rawson Avenues. Officers spoke with a 25-year-old Milwaukee woman who stated earlier in the evening she contacted a 26-year-old South Milwaukee man over a debt owed and began following him in her vehicle when he drove off. During the confrontation, a 19-year-old Milwaukee woman who was a passenger in the South Milwaukee man's car, brandished a firearm and threatened the 25-year-old Milwaukee woman. After the firearm was brandished, the South Milwaukee man drove away and the 25-year-old Milwaukee woman struck another vehicle. A 3-year-old Milwaukee girl was a passenger in the 25-year-old Milwaukee woman's vehicle and was not injured. The 25-year-old Milwaukee woman was arrested and taken to the Milwaukee County Criminal Justice Facility where she was charged by the Milwaukee County District Attorney's Office with Recklessly Endangering Safety and Child Neglect. Officers recovered the firearm from a residence in West Allis and located both the South Milwaukee man and the 19-year-old Milwaukee woman. The 19-year-old Milwaukee woman was arrested and referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct and Carrying a Concealed Weapon.

On October 30th, an officer on patrol noticed a group of people arguing near 15th and Rawson Avenues. Several in the group stated a 43-year-old South Milwaukee man was upset he was asked to leave a nearby business that had closed for the evening. The man continued to create a disturbance by talking loudly and he was arrested. He was taken to the police station where he was issued a citation for Disorderly Conduct.

WEAPONS VIOLATION

On October 21st, officers were dispatched to a residence in the 900 Block of Minnesota Avenue for a report of an unwanted person who was becoming violent. Officers spoke with a 61-year-old South Milwaukee man who stated a 35-year-old South Milwaukee woman entered his apartment while being chased by a 49-year-old South Milwaukee man who had a firearm. While officers searched for the man, he attempted to flee the residence by jumping out of a third story window. He was located outside in the yard and South Milwaukee Fire Department personnel responded to tend to injuries he received from the fall. A firearm located near the man was found to have been reported stolen from the city of Milwaukee and fentanyl was located during a search incident to arrest. A fence gate belonging to neighbors was also damaged. The man was arrested and taken to the hospital for his injuries. He was charged by the Milwaukee County District Attorney's Office with Felon in Possession of a Firearm, Possession of Narcotics, Domestic Violence Battery, Disorderly Conduct While Armed, Obstruction, and Criminal Damage to Property.

OPERATING WHILE INTOXICATED

On October 17th, officers were dispatched to the 3300 Block of Marina Road for a report of a vehicle parked and running with the driver appearing to be passed out. Officers located the vehicle and were able to wake up the driver, a 24-year-old South Milwaukee man. The man showed signs of impairment and he was arrested. He was taken to the police station and issued citations for Operating While Intoxicated-First Offense and Operating With a Prohibited Blood-Alcohol Concentration.

On October 28th, officers were dispatched to a report of a vehicle driving recklessly near Lake Drive and Hawthorne Avenue. Officers located the vehicle near North Chicago and Rawson Avenues and observed it go through a red light while driving in the wrong lane of travel. A vehicle stop was initiated and the driver, a 31-year-old Milwaukee woman, showed signs of impairment. Drug paraphernalia was located in the vehicle. She was arrested and issued citations for Operating While Intoxicated-First Offense, Operating With a Prohibited Blood-Alcohol Concentration, Red Traffic Signal Violation, Operating Left of Center, Operating Without Insurance, and Possession of Drug Paraphernalia.
