

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 11/14/22 – 11/27/22



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **399** calls for service.

VIOLATION OF COURT ORDER

On November 22nd, officers were dispatched to the 1200 Block of Missouri Avenue for a report of an individual at a residence in violation of a court order. Officers spoke with a 32-year-old Milwaukee woman who was found to have a confirmed felony warrant with the Milwaukee County Sheriff's Office. The woman also had a confirmed restraining order directing her to avoid the residence as a condition of bail. The woman became uncooperative and began shouting loudly as she was arrested. She was taken to the police station and turned over to Milwaukee County Sheriff's Office deputies on the warrant. She was charged by the Milwaukee County District Attorney's Office with Felony Bail Jumping and Resisting and Officer.

DISORDERLY CONDUCT

On November 14th, officers were dispatched to the 500 Block of 11th Avenue for a report of an unwanted person. Officers spoke with a 26-year-old South Milwaukee woman who stated a 30-year-old South Milwaukee man attempted to enter a residence and damaged a door during an argument. Officers spoke with the man who was intoxicated and became uncooperative. He was arrested and taken to the Milwaukee County Criminal Justice Facility. He was later charged by the Milwaukee County District Attorney's Office with Criminal Damage to Property and Disorderly Conduct-Domestic Violence Related.

RETAIL THEFT

On November 16th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual concealing items in a backpack and leaving the business without paying for them. Officers and store security located the individual, a 31-year-old Milwaukee man, and the items from the store were recovered. The man was arrested and taken to the police station where he was issued a citation for Retail Theft.

On November 27th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual switching tags on items and not paying for them. Officers spoke with a 40-year-old Oak Creek woman who admitted to switching tags and not paying for items. The woman was found to have been involved in two prior theft incidents at the business and had been previously trespassed from the store. She was arrested and taken to the police station where she was issued citations for Retail Theft and Trespassing.

DAMAGE TO PROPERTY

On November 24th, officers were dispatched to the 600 Block of Milwaukee Avenue for a report of individuals arguing. Officers spoke with a 27-year-old South Milwaukee man and a 24-year-old Wonder Lake, Illinois woman who were involved in the argument. During the argument the woman became upset and pulled a flower box off the side of a building in the 700 Block of Milwaukee Avenue. She was arrested and taken to the police station where she was issued a citation for Criminal Damage to Property.

OPERATING WHILE INTOXICATED

On November 19th, officers from the Oak Creek Police Department attempted to stop a vehicle driving erratically near South Chicago and Forest Hill Avenues. The vehicle fled from the Oak Creek officers and stop sticks were deployed by South Milwaukee officers. The vehicle continued to drive at an unsafe speed and officers terminated the pursuit. The vehicle was later located travelling slowly with flat tires and was eventually stopped near 14th and Manitoba Avenues. The driver, a 36-year old Milwaukee man, showed signs of impairment and was arrested. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-4th Offense, Eluding an Officer, and Operating After Revocation.
