

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *11/28/22 – 12/11/22*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **427** calls for service.

DISORDERLY CONDUCT

On November 28th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of a male and female fighting. Officers spoke with a 29-year-old Milwaukee woman and a 29-year-old Janesville man who were involved in an altercation. Witnesses stated the woman threw food on the ground and struck the man during the argument. She was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence related.

On December 6th, officers were dispatched to a residence in the 3600 Block of 9th Avenue for a report of an individual creating a disturbance. Officers spoke with a 43-year-old South Milwaukee woman who stated a 17-year-old South Milwaukee boy damaged property and threatened himself and others. The boy became uncooperative and he was arrested. He was issued citations for Disorderly Conduct and Resisting/Obstructing.

On December 11th, officers were dispatched to the 1400 block of Missouri Avenue for a report of individuals involved in an argument. Officers spoke with a 40-year-old South Milwaukee woman who stated she was involved in a verbal argument with a 29-year-old South Milwaukee man when a 30-year-old South Milwaukee man became involved in the argument. The two men then got into a physical confrontation but were separated prior to the arrival of officers. All were warned to avoid each other for the rest of the evening and the two men received citations for Disorderly Conduct for their involvement in the physical confrontation.

OPERATING WHILE INTOXICATED

On December 5th, officers were dispatched to the area near North Chicago Avenue and Hawthorne Avenue for a report of a hit and run accident where a vehicle struck a street sign and continued driving. Officers observed a damaged street sign and the striking vehicle was located in the city of Cudahy. The driver, a 61-year-old South Milwaukee woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-First Offense and Operating With a Prohibited Blood-Alcohol Concentration.

BATTERY

On December 10th, officers were dispatched to the 700 Block of Monroe Avenue for a report of a battery and theft. Officers spoke with a 31-year-old South Milwaukee woman who stated a 34-year-old Sheboygan man struck her and left with her phone and other property. Officers spoke with the man and he admitted to being involved in the argument with the woman. He was issued citations for Battery and Theft.

RETAIL THEFT

On December 1st, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual concealing items and leaving without paying for them. Officers spoke with a 51-year-old Cudahy woman who admitted to concealing the items. She was arrested and issued a citation for Retail Theft.
