

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *2/6/23 – 2/19/23*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **467** calls for service.

DISORDERLY CONDUCT

On February 7th, officers were dispatched to the area of South Chicago Avenue and Drexel Boulevard for report of an individual standing in traffic pounding on windows of passing vehicles. Upon arrival, officers were advised the individual went into a business in the 3100 Block of South Chicago Avenue and was swearing and making obscene gestures at customers. Officers spoke with a 47-year-old Milwaukee woman in the parking lot of the business who matched the description given. Officers were also advised the woman took coffee and donuts from the business without paying for them and spit on employees. The woman became uncooperative and continued to yell loudly before eventually being arrested. She was taken to the police station and issued citations for Retail Theft, Disorderly Conduct, Battery, and Resisting/Obstructing.

On February 10th, officers were dispatched to a residence in the 500 Block of Madison Avenue for a report of an individual creating a disturbance. Officer spoke with a 36-year-old South Milwaukee woman who stated a 36-year-old South Milwaukee man threw items around and broke furniture during an argument. The man was arrested and taken to the Milwaukee County Criminal Justice Facility. He was referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct/Domestic Violence related.

TRESPASSING

On February 18th, officers were dispatched to a business in the 2700 Block of South Chicago Avenue for a report of an individual refusing to leave the business. Officer spoke with a 46-year-old South Milwaukee man who was previously trespassed from the business on February 10th. Employees stated the man came into the business and threw a soda before refusing to leave. The man admitted to knowing he had been trespassed from the business and he was arrested. He was taken to the police station and issued a citation for Trespassing.

OPERATING WHILE INTOXICATED

On February 10th, an officer on patrol initiated a traffic stop on a vehicle driven by the registered owner who had a suspended driving status. The registered owner, a 31-year-old Milwaukee woman, showed signs of impairment. She admitted to smoking marijuana prior to driving and an open liquor bottle was located in the vehicle. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-First Offense, Operating While Suspended, and Possessing Open Intoxicants in a Motor Vehicle.

TRAFFIC OFFENSE

On February 7th, officers were dispatched to a report of a vehicle driving erratically near Drexel Boulevard and Nicholson Avenue. Officers located the vehicle in the 2900 Block of South Chicago Avenue and initiated a traffic stop. The driver, who did not show signs of impairment, originally provided false identifying information. She was eventually identified as a 32-year-old Milwaukee woman and was found to a revoked driving status. Marijuana and drug paraphernalia was located in the vehicle. The woman was arrested and taken to the police station where she was issued citations for Operating After Revocation, Possession of Marijuana, Possession of Drug Paraphernalia, and Obstructing an Officer.
