

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 4/17/23 – 4/30/23

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **487** calls for service.

DISORDERLY CONDUCT

On April 25th, officers were dispatched to the 3100 Block of South Chicago Avenue for a road rage complaint. Officers spoke with a 26-year-old South Milwaukee man who stated a vehicle followed him aggressively after he passed it in the 2700 Block of South Chicago Avenue. The man stated the other driver followed him to a business in the 3100 Block of South Chicago Avenue and punched him in the face as he tried to enter the business. Officers contacted the other driver who was identified as a 33-year-old South Milwaukee man and he admitted to being involved in the altercation and striking the 26-year-old man. He was arrested and issued citations for Disorderly Conduct and Battery.

On April 25th, officers were dispatched to the 1300 Block of Michigan Avenue for a report of an individual being threatened. Officers spoke with an 81-year-old South Milwaukee man who stated he was threatened by a 53-year-old South Milwaukee man. The 53-year-old man admitted to confronting the 81-year-old man and he was arrested and issued a citation for Disorderly Conduct.

BATTERY

On April 28th, officers were dispatched to the 1200 Block of Marquette Avenue for a report of individuals involved in an altercation. Officers spoke with a 29-year-old South Milwaukee woman and a 35-year-old South Milwaukee woman who were involved in a verbal argument that turned into a mutual fight. Both women were arrested and issued citations for Battery.

RETAIL THEFT

On April 21st, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual eating food items from the store without paying for them. Officers spoke with a 30-year-old Cudahy woman who admitted to eating the food items. The woman also had other store merchandise concealed in her purse. Drug paraphernalia was also located on her person. She was arrested and issued citations for Retail Theft and Possession of Drug Paraphernalia.

On April 21st, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an intoxicated subject eating food items without paying for them. Officers spoke with a 38-year-old Cudahy man who was also found to have concealed other store merchandise in his jacket. The man had a confirmed warrant with the Cudahy Police Department for Theft and drug paraphernalia was located on his person. He was arrested and issued citations for Retail Theft and Possession of Drug Paraphernalia. He signed a Personal Recognizance Bond on the warrant.
