

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *5/15/23 – 5/28/23*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **558** calls for service.

BATTERY

On May 25th, officers were dispatched to the 700 Block of Montana Avenue after a citizen reported a female being battered by four individuals. Officers spoke with a 22-year-old Adams woman who stated she was sitting outside when a vehicle drove up and four individuals got out and began to strike her. The individuals left the scene when a 23-year-old South Milwaukee man intervened. An investigation identified two of the individuals involved as an 18-year-old Milwaukee woman and a 15-year-old Milwaukee girl. Both admitted to their involvement in the incident which was a result of social media communications between all involved. Both were arrested and issued citations for Battery and Disorderly Conduct.

CRIMINAL DAMAGE TO PROPERTY

On May 20TH, officers were dispatched to the 300 Block of Southtowne Drive for a report of individuals arguing. Officers spoke with a 25-year-old South Milwaukee man and a 24-year-old Chicago woman who were involved in an argument. An investigation revealed that while moving her belongings out of an apartment, the Chicago woman poured bleach on the man's electronics equipment and damaged it. She was arrested and taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Criminal Damage to Property-Domestic Violence Related.

DRUG INVESTIGATION

On May 27th, officers were dispatched to the 1300 Block of Manitoba Avenue for a report of a vehicle parked with two individuals who appeared to be sleeping. Officers spoke with a 35-year-old Cudahy woman and a 39-year-old Oak Creek man. The man was found to have a Felony warrant with the Wisconsin Department of Corrections for a probation violation. The woman turned over a vial with drugs in it to officers. The drugs later tested positive for crack cocaine. Both were arrested and the woman was referred to the Milwaukee County District Attorney's Office on a charge of Possession of Crack Cocaine. The man was taken to the Milwaukee County Criminal Justice Facility on the warrant.

WARRANT ARREST

On May 26th, officers were dispatched to a business in the 100 Block of North Chicago Avenue for a report of an individual harassing customers. Officers spoke with a 27-year-old Milwaukee man who was found to have a confirmed fully extraditable felony warrant with the Milwaukee County Sheriff's Office. The man was also found to be in possession of drug paraphernalia. He was arrested and taken to the police station where he was issued a citation for Possession of Drug Paraphernalia. He was turned over to deputies from the Milwaukee County Sheriff's Office on the warrant.

RETAIL THEFT

On May 19th, officers were dispatched to a business in the 200 Block of North Chicago Avenue after employees reported two females left without paying for a large amount of merchandise. Both females were reported to have left the area in a vehicle. An officer on patrol located the vehicle and initiated a traffic stop in the city of Cudahy. The driver, a 20-year-old Milwaukee woman, and passenger, an 18-year-old Milwaukee woman, admitted to taking the merchandise from the store. The missing merchandise was located in the vehicle. The 18-year-old woman was on probation for retail theft. Both women were arrested and taken to the Milwaukee County Criminal Justice Facility. They were referred to the Milwaukee County District Attorney's Office on charges of Felony Retail Theft.
