

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 6/26/23 – 7/9/23



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **536** calls for service.

WEAPONS VIOLATION

On July 4th, a motorist reported individuals in a black Jeep waved a gun out the window while driving near North Chicago and Rawson Avenues. The vehicle was located near Park Avenue and Lake Drive and officers spoke with the occupants. A rifle was located in the vehicle along with an open liquor bottle. A 21-year-old Milwaukee man was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct While Armed. Another 21-year-old Milwaukee man was issued a citation for Obstructing and another 21-year-old Milwaukee man was issued a citation for Open Intoxicants in a Motor Vehicle.

STOLEN VEHICLE RECOVERY

On July 4th, officers received information a stolen vehicle from the city of Milwaukee was in the parking lot of a business in the 200 Block of North Chicago Avenue. Officers located the vehicle unoccupied and with the assistance of store employees and surveillance video were able to identify the driver as a 27-year-old Milwaukee man. He was located and arrested. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Operating a Vehicle Without Owner's Consent. The vehicle was towed to a tow lot where it was picked up by the owner.

DISORDERLY CONDUCT

On July 7th, officers were dispatched to the area of Park Avenue and Lake Drive for a report of an intoxicated individual in the roadway. Officers located a 40-year-old South Milwaukee man who was intoxicated and had injuries from a broken glass beer stein he was holding. South Milwaukee Fire Department personnel responded to the scene to evaluate the man's injuries. The man became uncooperative with officers and fire department personnel. He was eventually taken to the hospital by fire department personnel for treatment of his injuries. The man was issued a citation for Disorderly Conduct.

RETAIL THEFT

On June 30th, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of an individual taking items off the shelves and eating and drinking them. When asked to pay for the items, the individual refused. Officers spoke with the individual who originally provided false identification before eventually being identified as a 33-year-old Milwaukee woman. She was arrested and taken to the police station where she was issued citations for Retail Theft and Obstructing.

TRESPASS

On June 29th, officers were dispatched to a business in the 2300 Block of 10th Avenue for a report of an individual leaving the store without paying for items. The same individual was trespass from the store on June 27th for throwing items at the store and driving recklessly in the parking lot. The store manager reported the individual was a former employee and using store records and surveillance video the individual was identified as a 21-year-old South Milwaukee woman. The woman was issued a citation for Trespassing.
