

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 7/10/23 – 7/23/23



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **532** calls for service.

OPERATING WHILE INTOXICATED

On July 14th, an officer on patrol noticed a vehicle driving without headlights following another vehicle very closely near South Chicago and Forest Hill Avenues. A traffic stop was conducted in the 8400 Block of South Chicago Avenue in the city of Oak Creek. The driver, a 45-year-old Sheboygan man, showed signs of impairment. He was arrested and taken to the Milwaukee County Criminal Justice Facility. He was referred to the Milwaukee County District Attorney's Office on charges of Operating While Intoxicated-3rd Offense and Operating With a Prohibited Blood-Alcohol Concentration. He was issued citations for Operating After Revocation, Failure to Install Ignition Interlock Device, and Operating Without Headlights.

WEAPONS VIOLATION

On July 4th, an officer on patrol observed a vehicle travel through the red light at 10th and Milwaukee Avenues and a traffic stop was conducted in the 1000 Block of Michigan Avenue. The driver, a 27-year-old Milwaukee man, had a suspended driving status and produced a Concealed Carry Permit. The man admitted to carrying a firearm and one was located on his person. The man's Concealed Carry status was found to be revoked and drug paraphernalia was located in the vehicle. He was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Carrying a Concealed Weapon. He was issued citations for Operating After Suspension, Failure to Obey Signal (Red Light), and Possession of Drug Paraphernalia.

DISORDERLY CONDUCT

On July 22nd, officers were dispatched to a residence in the 2600 Block of South Chicago Avenue for a report of two individuals fighting. Officers spoke with a 29-year-old South Milwaukee man and a 36-year-old South Milwaukee woman. A witness stated the woman punched the man. The man was found to have confirmed traffic warrants with the city of Burlington. The man was arrested on the warrants and he posted bond on them at the police station. The woman was arrested and taken to the Milwaukee County Criminal Justice Facility. She was referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence Related.

NOISE COMPLAINT

On July 22nd officers were dispatched to the 400 Block of Hawthorne Avenue for a report of a party with loud individuals inside a garage. Numerous individuals were located talking loudly. The homeowner was contacted and was unaware a party was occurring. He returned home and the individuals left the area. A 17-year-old South Milwaukee girl was issued a citation for Unnecessary Noise.

TRESPASS

On July 22nd, officers were dispatched to a report of individuals being loud after hours in the 1800 Block of Hickory Avenue. Officers spoke with a 19-year old Milwaukee man, a 19-year-old Oak Creek man, a 19-year-old St. Francis man, and an 18-year-old Hales Corners man. Drug paraphernalia was also found in a parked vehicle belonging to the Milwaukee man. The Milwaukee man was issued citations for Trespassing and Possession of Drug Paraphernalia while the Oak Creek, St. Francis, and Hales Corners men were issued citations for Trespassing.
