

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *10/16/23 – 10/29/23*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **456** calls for service.

DISORDERLY CONDUCT

On October 24th, officers were dispatched to a building in the 1900 Block of 10th Avenue for a report of individuals causing a disturbance. The individuals had left the building prior to the arrival of officers. An investigation determined the same individuals were involved in numerous other disturbances purposely created for social media entertainment and they were both identified as 20-year-old South Milwaukee men. They were both issued Disorderly Conduct citations for each of the disturbances they were involved in.

On October 26th, officers were dispatched to a business in the 900 Block of Milwaukee Avenue for a report of an individual causing a disturbance and refusing to leave. Upon arrival, officers observed a 48-year-old Cudahy man yelling at an employee. The man continued to yell loudly and use profane language despite being advised not to by officers. A 32-year-old South Milwaukee man who was with the Cudahy man left without incident. The Cudahy man was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

TRESPASS

On October 28th, officers were dispatched to a residence in the 800 Block of Minnesota Avenue for a report of an individual sleeping in the basement who did not live there. Officers located a 26-year-old South Milwaukee man who had been previously warned he was not welcome at the residence. He was arrested and taken to the police station where he was issued a citation for Trespassing.

OPERATING WHILE INTOXICATED

On October 22nd, officers were dispatched to a report of a Hit and Run accident in the 700 Block of Marquette Avenue. Officers located a parked vehicle with extensive damage and debris in the roadway. Soon thereafter, a citizen reported a damaged vehicle driving near 5th and Clark Avenues. Officers located this vehicle and a traffic stop was initiated. The driver, a 36-year-old Sycamore, Illinois woman showed signs of impairment. Debris collected from the accident scene matched the damage on the vehicle and the woman was arrested. She was taken to the police station where she was issued citations for Operating While Intoxicated-First Offense and Hit and Run. She was released to a sober responsible adult.

WARRANT ARREST

On October 29th, an officer on patrol observed a vehicle fail to complete stop at the stop sign at 9th and Columbia Avenues and a traffic stop was initiated. The driver, a 30-year-old Milwaukee man, was found to have a confirmed warrant with the Milwaukee County Sheriff's Office for Disorderly Conduct and Criminal Damage to Property-Domestic Violence Related. The man was arrested on the warrant and taken to the police station where he was turned over to deputies from the Milwaukee County Sheriff's Office. He was warned and advised on the stop sign violation.

RETAIL THEFT

On October 28th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual leaving the store without paying for items. Officers located a 26-year-old Evanston, Illinois man nearby who matched the description given. The man was in possession of the unpaid for merchandise and he was arrested. He was taken to the police station and issued a citation for Retail Theft.
