

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 10/30/23 – 11/12/23***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **407** calls for service.

### **DISORDERLY CONDUCT**

On November 4<sup>th</sup>, officers were dispatched to a residence in the 1300 Block of Manitoba Avenue for a report of an individual being disorderly. Officers spoke with a 20-year-old South Milwaukee woman who stated a 20-year-old South Milwaukee man pushed her off a chair after she failed to bring him food from a restaurant. The man also broke a mirror before leaving the residence. The man was located at a nearby residence and was arrested. He was taken to the police station where he damaged property in a jail cell. He was issued a citation for Criminal Damage to Property before being taken to the Milwaukee County Criminal Justice Facility. He was referred to the Milwaukee County District Attorney's Office on a Domestic Violence related charge of Disorderly Conduct.

On October 31<sup>st</sup>, officers were dispatched to a restaurant in the 2900 Block of South Chicago Avenue for a report of an individual being disorderly. Officers spoke with a 17-year-old Cudahy girl who stated another patron bought a man a sandwich. The man wanted a larger sandwich than what was purchased for him and when told he would receive the sandwich that was paid for, he began to yell loudly and threatened the girl. Other witnesses provided similar accounts and directed officers to a 58-year-old Milwaukee man nearby who matched the description given. The man admitted to being in the restaurant and he was arrested. Drug paraphernalia was located in his pocket. He was taken to the police station and issued citations for Disorderly Conduct and Possession of Drug Paraphernalia.

## **SUSPICIOUS ACTIVITY**

On October 30<sup>th</sup>, officers were dispatched to the 1800 Block of Rawson Avenue for a report of an individual wearing a wig attempting to enter a locked building. Officers spoke with a 29-year-old Milwaukee man who was inside a parked vehicle and matched the description given. The man was found to have a confirmed felony warrant with Probation and Parole for Robbery. He was arrested on the warrant and taken to the police station. Drug paraphernalia was also located on his person. He was issued a citation for Possession of Drug Paraphernalia before being taken to the Milwaukee County Criminal Justice Facility on the warrant.

## **OPERATING WHILE INTOXICATED**

On November 6<sup>th</sup>, an officer on patrol observed a vehicle operating without taillights near Nicholson and Rawson Avenues and a traffic stop was initiated near Nicholson and Milwaukee Avenues. The driver, a 57-year-old South Milwaukee man, showed signs of impairment. He was arrested and taken to the police station. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-Third Offense.

## **RETAIL THEFT**

On November 8<sup>th</sup>, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual leaving the store without paying for items. Officers spoke with a 20-year-old St. Francis man who was being detained by store security. The man was in possession of the unpaid for items and marijuana was located on his person. He was arrested and issued citations for Retail Theft and Possession of Marijuana.
