

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *12/11/23 – 12/24/23*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **469** calls for service.

DISORDERLY CONDUCT

On December 23rd, officers were dispatched to the 1400 Block of Madison Avenue after a citizen reported an unknown person inside his parked vehicle. Officers spoke with a 42-year-old South Milwaukee woman who was intoxicated. The woman stated she slept in the vehicle after drinking the night before. The woman was arrested and issued a citation for Disorderly Conduct before being released to a sober, responsible adult.

On December 11th, officers were dispatched to the 1300 Block of Milwaukee Avenue for a report of an individual being disorderly and refusing to leave a business in the area. Officers located a 34-year-old South Milwaukee woman nearby who matched the description given. The woman refused to leave the area and was intoxicated and uncooperative with officers. She was arrested and taken to the police station where she was issued citations for Disorderly Conduct and Resisting/Obstructing.

On December 13th, officers were dispatched to a business in the 1000 Block of Milwaukee Avenue for a report of a disorderly individual. Officers spoke with a 78-year-old South Milwaukee man who witnesses stated used profane language and threatened employees. The man was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

DAMAGE TO PROPERTY

On December 17th, officers were dispatched to a restaurant in the 2200 Block of 10th Avenue for a report of a disorderly individual. Officers located a man sitting at a table and a broken vase on the floor. The man was intoxicated and refused to identify himself. The business owner stated he provided the man food free of charge after the man stated he was homeless and hungry. While eating the food, the man became agitated and broke the vase. He was identified as a 60-year-old West Allis man and was found to have three confirmed warrants with the Milwaukee County Sheriff for Disorderly Conduct. He was arrested and issued a citation for Criminal Damage to Property and turned over to a Milwaukee County Sheriff's deputy on the warrants.

RETAIL THEFT

On December 16th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a theft complaint. Officers spoke with a 57-year-old Cudahy man who was observed by employees selecting merchandise and then attempting a fraudulent return to obtain money for the merchandise which was not paid for. The man admitted to the fraudulent returns and was arrested and issued a citation for Retail Theft.

On December 23rd, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of individual in the store who had been previously trespassed. Employees stated a 40-year-old Milwaukee man who was previously trespassed, entered the store and took a bottle of soda into a restroom without paying for it. Officers spoke with the man and located an empty soda bottle in the restroom. He was arrested and issued citations for Retail Theft and Trespassing. While speaking with officers the man claimed to have medical issues and was taken to a hospital by a South Milwaukee Fire Department ambulance.
